SUBJECT: Great Pond Boat Racks 2019 Season Report

<u>Introduction</u>

2019 is the tenth year of boat rack storage at Great Pond managed by the Town of Cape Elizabeth. The Boat Rack Program is operated on land owned by the Sprague Corporation in accordance with the terms of the easement granted to the Town of Cape Elizabeth. Below is a summary of this season's highlights.

Boat Permit Issuance

Permits were again issued on a lottery system where a record 137 permit applications were submitted, almost 40 more than was received the previous year, for 32 slots. A second drawing was held from the original pool of applicants when 3 lottery winners declined the permit. Permit holders continue to be from all parts of town.

Periodic inspections

Staff inspected boat rack use on 4 dates during the season. After 2 inspections in June, 8 boat rack slots were empty. Based on 4 inspections, only 1 boat slot was not used for storage this season.

All boats must be removed from the racks by the first Saturday in December. Staff inspected the racks on December 16, 2019 to find 7 boat slots still in place. Permit holders were notified to immediately remove boats. On January 6, 2020, the Public Works Department removed 3 boats, one of which appeared to be owned by a permit holder.

Conclusion

No changes to the program are recommended for the 2020 season.
