Thank you for the discussion on the evaluation process for the 7 design options yesterday evening. I apologize that I could not present my spreadsheet more appropriately due to the technical difficulties, but I was glad that the dialogue seemed to result in a rough process for evaluating these options. As I understand it based on last night's discussion, the evaluation process for the SBAC is as follows:

- Each SBAC member will choose the three options that they view as being the best three fits for the community moving forward.
- These three options are to be graded on the following criteria:
  - Lifespan of the proposed solution
  - The solution's impact on/disruption to the teachers and students
  - The solution's tax implications
  - How well the solution meets the Town's educational needs

I did not hear that there was a set grading scale to be used, only that SBAC members should be prepared to speak on how each option addressed each criteria.

Please let me know if anyone is in disagreement with what I've outlined above and/or if there are any additional materials you require to assist you with this process.
