Truly appreciate the tireless/thankless work you've put into Cape school project. As you meet this week to decide on which proposal to push forward, Kira and I strongly encourage you to pick Option E.

(borrowing the below reasons from Joy Engel because she's nailed it):

- Option E is the most financially responsible choice – we will pay less as taxpayers in the long term. For Cape residents on fixed budget, this is imperative.
- Option E sets the town on the path of creating a master plan, something that will benefit residents today and far into the future.
- Option E has the least amount of student disruption.
- The cost difference between C and E is minimal, but with E option we get a chance to 'restart the clock' through a new school.
- Option E creates a safe, long-term solution for the issues that have plagued our town for more than 3 decades.
