The district collects roughly \$43,000 in HS athletic fees each year (\$120 per student). 15% of the HS athletic budget is funded by this money.

The District only pays Middle School coaching stipends. All other costs were transferred to Community Services to be paid by families – yearly \$40 administrative fee + \$50 per sport. This covers roughly \$39,000 in athletic expenses. In addition there is a \$25 refundable deposit for uniforms.

At this point, Falmouth is studying the possibility and plans could go one step further by categorizing sports in a 1-3 range and to charge fees accordingly. Yarmouth is not at this time. MSAD #51 is thinking about fees for next year, and it was noted that Scarborough did but does not any longer.

SPORTS TICKET REVENUE

- The Football Play-off gate (Quarter, Semi and Regional Final) is divided into thirds (Host/Opponent and Campbell Conference). The Maine Principals Association (MPA) collects the gate at the State Championship game.
- Ice Hockey Play-off gate the host team collects the Quarter Final gate. Regional and State Championship games are collected by the MPA.

• Basketball play-offs are all held at an independent site and the gate is collected by the MPA

Gate Fees

- Football, Boys Ice Hockey and Boys/Girls Basketball are the only sports that collect a gate.
- Football and Ice Hockey Boosters receive any remaining gate revenue after expenses (Timers, Ticket takers, Police, Rescue, additional site supervisors)
- Basketball All of the gate revenue is collected and given to the business office.
 The Basketball Boosters do not receive gate revenue after expenses have been paid.
- The Boosters are required to give the gate to the athletic administrator after each game and the money is put into a separate account in the CE Business Office. At the end of the season and after all expenses have been paid, the business office sends a check to the Football and Ice Hockey Booster Reps.
- Portable Restrooms are not budgeted for in the Athletic Budget. Fortunately some of the boosters and youth organizations have contributed to this expense. We need port-a-potties on the school grounds for the players and spectators.
- Football, Basketball, Ice Hockey timers are paid out of gate receipts.

Based on most recent state data -2008 – Cape Elizabeth's per pupil expenditure was \$357, below the state average of \$570.

Budgeted for 09-10 is \$625,156.

The EPS funding formula for 09-10 for transportation includes 90% of actual expenses for transportation from 2 years back (07-08) 90%=\$507,735.

E-texts require all students to have laptops. To provide all students 5-12 with laptops through the existing MLTI program cost would be \$242/student per year. The cost would equal about 850 students grades 5-12 (minus the 7th & 8th graders that already have laptops through MLTI). $850 \times $242 = $205,700 \text{ per year}$. NetBooks or Tablet computers might provide alternatives to the MLTI laptops at potentially less cost but there are questions about durability.

E-texts cost roughly the same as printed versions (actually \$1.25 per student more) with a six year site license that will need to be renewed after six years. There are some Open Source textbook projects out there (like in California) or at ConneXions (http://cnx.org). These open source (free) options might be valuable if the materials fit into our curriculum.

The pilot for Virtual High School at Cape had virtually no enrollment and since has been dropped. Some successful distance learning is happening through UMO with one HS student with no costs to the district (paid for by State and student).

- Playing in the SMAA would not necessarily reduce travel. There would still be significant travel (Noble, Sanford, Marshwood, Massabesic, Windham).
- The best-case scenario would be a combination Class A/Class B Schedule based on competition and geography. This could happen if the current MPA Heal Point System was eliminated.
 - This is a recommendation the principals would have to make to the MPA Interscholastic Committee.
 - o Jeff Shedd has formally written the MPA with this suggestion.
- The Heal Point System used for Play-off participation is a major factor driving the lack of conference cross-overs (Class A Schools competing against Class B Schools)
 - Class A Schools are worth 40 Points, Class B 35 points, Class C 30 points, and Class D 25 Points.
 - The MPA Interscholastic Committee voted last year to lower the play-off participation number from 2/3 to 1/2 of the teams eligible for play-off

participation. If CE participated fully in Class A sports very few CE teams would be eligible for post-season play.

- Replacement of high school locker room rooftop air exchanger with a unit that incorporates a heat recovery unit.
- Added a variable speed drive to middle school circulators
- Added load shed schedule to control peak electric demand at both schools
- Replaced all roof top exhaust fans High School
- Light motion sensors and split hallway lighting installed
- Lighting upgrades installing energy efficient bulbs
- Town wide energy audit

Reduced number of KWHs in 08/09 by 215,000 from 07/08 - a 10% decrease and this year (09/10) reductions continue on order of about 15% mostly a result of system wide multi-year project of installing more energy efficient bulbs, motion sensors and split hallway lighting.

FOOD SERVICES
