## Conservation Commission Minutes August 13, 2013

Meeting called to order at 7:05 p.m.

1. The Chair discussed conservation and leadership in Cape Elizabeth. It is gratifying to see the large group of citizens who come to our meetings. He cited conservation leaders in Cape Elizabeth who had great impact on our community. The Commission displays, and will continue to display, the following qualities: visible, personally involved, optimistic, seeking input, fair, minimize status differences, respect private property rights, work to build consensus, focused, adaptable. The Chair does not support trails on farms. The Commission is an ally of farmers in Cape Elizabeth.

## 2. Public Comments, limited to 15 minutes total.

Penelope Jordan, an owner of Jordan Farm. It is ironic that we are in a conference room named after a person who is a leader in this community. To have to attend seven or eight meetings is a burden. Her father would say this is not 1970 or 1980, there is a lack of respect for property owner rights. She would like to see trails 8A and 8B removed from the conceptual map. The table in the Greenbelt Plan now says wooded. The property owner spoke to the Commission and objected to the trail.

Kelly Gordon, Hannaford Cove Road. She has young children, there are 10 children under the age of ten on that road, she is concerned about safety. She is opposed to Trail #29, which will attract people to come to a lighthouse. There is commercial traffic and it will be difficult to distinguish between private and commercial users. Parking is also a concern.

Martha Duncan, Two Lights Road. She brought pictures from Sunday night, showing people parked illegally. There were cars on line up to Two Lights Terrace, there was no way a rescue vehicle could get down there. There is already an issue with parking.

Nyssa Kourakos, 15 Two Lights Road. The traffic there is already frightening, adding to that would increase the parking and safety problems. Thousands of people go to The Lobster Shack. Trail #29 is not in keeping with the rest of the Greenbelt.

Kate Sprague Gilbain, 226 Bowery Beach Road. She recommends distinguishing between the potential trail map, which should be used for planning, and the Greenbelt Trail Map, which should show only current trails open to the public. Combining the two causes confusion. Her family runs the Spurwink Farm, with 40 horses, and women who drive carriages. Trail #16 goes through Spurwink Farm, it is used by them with carriages. She has observed that people do strange things around horses.

Tom Egan, 41 Hannaford Cove Road. He is also principal and manager of Appletree Cottage LLC, a little cottage on an open field. He maintains Captain Elliot Road and Sunrise Drive. He takes pride in maintaining Hannaford Cove Road for neighborhood walkers. He bought the two roads in June, so that they could be preserved. He does not want people from away streaming in from the Lobster Shack.

Hilda Khalidi, 19 Pilot Point Road. She has been to several meetings, and encourages the Commission to vote tonight on trails.

2. Minutes of July 9, 2013 were reviewed and unanimously approved.

Revised minutes of May 14, 2013 were reviewed and unanimously approved. Revised minutes of March 12, 2013 were reviewed and unanimously approved.

3. Correspondence.

Letter from the Knapps regarding Trail #29, which they oppose. Letter and petition from J. Breau regarding Trail #26.

4. Greenbelt Plan Trails.

Trail #1; 5-0. A Commissioner stressed that we are voting on the idea of making a connection or potentially siting a trail in a location, not on a specific trail placement.

Trail #2; A lot of this marsh is in the City of South Portland, and their Commission is starting to consider a boardwalk there.

<u>Motion</u>: To extend Trail #2 across the town-owned land called Ferne Peddy Lots. Passed unanimously.


