Greetings Maureen,

I work for the National Park Service Rivers, Trails, and Conservation Assistance program (which helps organizations and communities develop land and water trails) and am currently helping the Maine Island Trail Association (MITA) with a project to extend the Maine Island Trail south and west from Portland. We are planning a meeting for people at the northern end of this stretch of coast who might be interested in learning more and offering feedback about MITA's plans. I am writing to ask whether you or perhaps a member of the Cape Elizabeth Conservation Commission would like to attend the meeting? Over the past few years MITA has been increasing its presence along the southern coast in an effort to expand our recreational water trail and broaden the reach of our boater education and stewardship activities.

In order to gather local input and feedback, we've hosted a series of meetings with various organizations, community members and other stakeholders in different towns/regions. We've already held meetings in Kittery, York, Wells and Saco/Biddeford, and now we're trying to convene a group of folks in the Scarborough/Cape Elizabeth area who are knowledgeable about this stretch of coast and/or the local recreational boating scene.

Would you be able to attend a stakeholder meeting later this month? Do you have time available on 9/24, 9/25 or 9/26?
