SUBJECT: Great Pond Boat Racks, 2015 and 2016 Season Report

<u>Introduction</u>

2016 is the seventh year of boat rack storage at Great Pond, managed by the Town of Cape Elizabeth. The Boat Rack program is operated on land owned by the Sprague Corporation in accordance with the terms of the easement granted to the Town of Cape Elizabeth. Below is a summary of the last 2 seasons' highlights.

Boat Permit Issuance

The number of permit applications is consistently in the low 80's. Thirty-two permits are issued using a lottery system. Both years, 2 lottery winners declined the permit and follow-up drawings were done from the applicant pool to award the last permits. Permit holders live all over town.

Boat Rack Use

In 2015, 4 permit holders did not use their slots to store a boat. In 2016, permit holders were encouraged to get their boats in place by July 4th, but 3 boat slots still remained unused. Anecdotal information is that applicants who are not successful in the lottery will contact permit holders who are not using their slot and arrange to use their boat slot, so non-use by permit holders may be higher.

Periodic inspections

Town staff periodically visit the boat racks. Compliance with boat storage rules is very high, with an average of 1 canoe a year requiring removal for storage off the racks.

In 2015, two permit holders left their boats on the racks after the season ended. They were contacted and promptly removed the boats. In 2016, six boats remained after the season. The permit holders have been notified to remove the boats or risk removal by the town.

Conclusion

This remains a very popular program and compliance with the boat rack rules is also strong. Absent permission from the Sprague Corporation to add a third rack, demand will far exceed supply of available boat rack slots.
