SUBJECT: Latter Day Saints Parking Lot Site Plan Amendment

<u>Introduction</u>

The Town of Cape Elizabeth is requesting an amendment to the previously approved (1987) Church of Latter Day Saints Site Plan, located at 29 Ocean House Rd to replace 2 parking spaces with a biofiltration unit. The application will be reviewed for compliance with Sec. 19-9, Site Plan Regulations.

Procedure

- The Planner will provide a summary of the project within the context of town regulations.
- The Board should begin by having the applicant summarize the project.
- •The Board should then make a determination of completeness. If the application is deemed incomplete, Board members should identify the information needed to make the application complete and no substantive discussion of the application should occur. If the application is deemed complete, substantive discussion may begin.
- The Board should then open the public hearing scheduled for this evening.
- The Board may begin discussion.
- When discussion ends, the Board has the option to approve, approve with conditions, table or deny the application.

Summary of Completeness

Attached are the completeness checklist and the comments of the Town Engineer. Below is a summary of possible incomplete items:

This application is an amendment to a site plan approved in 1987 for expansion of the parking lot, so several submission items have been identified as not applicable.

Site Plan Review Standards

Below is a summary of application compliance with the Site Plan standards, Sec. 19-9-5.

A. Utilization of the Site

The biofiltration unit is located in a developed portion of the site.

B. Traffic Access and Parking
