Introduction

Patrick Tinsman is requesting reapproval of a mixed office/restaurant/8 apartments development located at 1226 Shore Rd. The Planning Board granted site plan approval with conditions on October 20, 2017. Necessary plan revisions to comply with the conditions resulted in a need for amendments to the site plan approval. The approval expired before the applicant returned for amendments, so a reapproval of the development is proposed, subject to compliance with Sec. 19-9, Site Plan regulations, and Sec. 19-6-4(d)(3) Town Center Design requirements.

Procedure

- The Board should begin by having the applicant introduce the project.
- •The Board should then make a finding of completeness. If the application is deemed incomplete, board members should identify the information needed to make the application complete and no substantive review should begin. If the application is deemed complete, substantive review may begin.
- The Board should decide if a site walk and/or public hearing will be scheduled.
- At the close of discussion, the Board has the option to approve, approve with conditions, table or deny the application.

Summary of Completeness

The completeness checklist and the Town Engineer's comments are attached.

Several plans and other information included in the October 20, 2017 approval have not been resubmitted. The following chart summarizes the information submitted and included in the October 20, 2017 approval and the information submitted for this meeting.

The board can, by motion, reference all previously submitted material. Two Planning Board members have not been able to review any referenced materials.
