#### **Committee Appointments Update**

RM informed the Committee members that they would be starting out the year with 5 members. The Town Council Appointments Committee did not have enough interested candidates to fill the two vacancies. RM suggested that if anyone knows of interested candidates wishing to serve on the Committee they should contact Debra Lane, the Town Clerk. RM added that the Recycling Committee plays an important role in the community's commitment to recycling and it has been a tremendous help to him during his tenure.

# **Committee Member Updates & Correspondence**

MF reported that he went to the Middle School cafeteria to observe recycling practices. He spoke with the lead custodian (Donny Darling) about how they handled and transported recyclables to the containers outside. He reported that they are putting the recyclables in clear plastic bags, which Ecomaine is accepting for the time being. He also reported there are some challenges internally with the sorting program. He contacted Troiano Waste (the Town's current hauler) and Ecomaine to discuss transportation options for the MS school. There was a general discussion about separation and recycling practices in the schools by the custodial staff. MF suggested it might be helpful if committee members could help educate students in the cafeteria during lunch times.

RM suggested committee members might want to visit nearby schools, such as Scarborough to see how they handle separation and recycling in their respective cafeterias. TF offered to contact Waynflete School in Portland.

# **Council Action on Proposed Retail Packaging Ordinance**

The proposed ordinance was on the agenda of the December 12<sup>th</sup> meeting of the Town Council. RM attended the meeting along with AM and JM. After a brief discussion and some questions by the Councilors, they voted to forward the proposal on to the Town Council's Ordinance Committee for further consideration. The next meeting of the Ordinance Committee is scheduled for Tuesday, January 17, 2017 @ 12:00 PM at the Town Hall. The proposal is listed on the agenda, but no comprehensive discussion is planned, according to RM. RM suggested it might be helpful for the Chair (or other Committee members) to be present.

#### **Education & Outreach**

TF offered to draft an article about Ecomaine's recent prohibition on plastic bags in the single-stream recycling program. There was brief discussion about Ecomaine's public service announcement related to Holiday recycling of wrapping paper. The Committee thought it was helpful and informative. TF offered to draft an article about the topic for next December's Cape Courier.

MF reported that Ecomaine's Environmental Educator (Katrina Vanhuizen) is available to come speak in the schools.

KL suggested the Committee volunteer at the Swap Shop for a day as they have done in the past. RM again stated his appreciation for the efforts of the Swap Shop volunteers and said that it would be good for the Committee to introduce themselves to them.

#### **Other Business**

MF offered to contact with the School's Curriculum Director about recycling education.
