Review of Town Council Meeting Held April 9, 2012

Mr. Governali reviewed the April 9 Town Council meeting re: Riverside Cemetery Master Plan Update, stone wall and fees.

The town council approved the master plan update and fee schedule as presented. They also approved funding from the general fund in the amount of \$45,000 to complete the stone wall section on Route 77.

Update – Stonewall Expansion

Director of Public Works Robert Malley has prepared a request for proposals for the completion of the stone wall. Bids are due Thursday, June 14, 2012 at 2:00 p.m. at Town Hall.

Status of Fiscal Year 2013 Budget

The town council will vote on the budget including the cemetery fund at the May 14 meeting. The budget was reviewed during budget deliberations.

Chairman Timberlake received a letter from Sharon Murray, Ocean House Road. Mrs. Murray expressed her concern about the Trustees considering selling lots to non-residents and encouraged them to uphold the rules banning artificial flowers.

Chairman Timberlake had already responded to Mrs. Murray clarifying the *possible* sale of lots to non-residents was in the context of allowing non-residents to purchase in the niche walls only. One of the reasons is to have an option for those who have applied to the Trustees and have been denied.

The Trustees appreciate Mrs. Murray writing to them. Chairman Timberlake will let Mrs. Murray know that they will take measures to remind lot owners of the rules including an article on the town's website and possibly in the Cape Courier.

David Jones provided the following information.

Number of available lots = 669 (256 cremains 413 full size). This number <u>excludes</u> build out of the final phase.

Niche wall prices

Calvary \$1400 - \$1500 includes opening charge

Brooklawn \$1000 - \$1400 (bronze) \$2000 - \$2500 (granite)
