<u>Moved by Jessie Timberlake and Seconded by Gerald Sherry</u> to deny the request of Deborah Sangster Schonbak to purchase a cremation lot for her and her late husband. Although Mrs. Schonbak was raised in Cape Elizabeth she moved away establishing residency elsewhere for 40+ years. Except for her grandparents there are no other relatives buried at Riverside. (3 yes) (0 no)

Note: The Town's record indicate Mrs. Schonbak's mother Carol Sangster purchased lots years ago but never used them. Mrs. Schonbak and her sister have burial rights to the lots.

Laurie Tuchman

<u>Moved by Sharon Smarc and Seconded by Jessie Timberlake</u> to deny the request of Laurie Masterton Tuchman to purchase lots. Although Mrs. Tuchman was raised in Cape Elizabeth she moved away establishing residency elsewhere for 40+ years. Except for her parents there are no other relatives buried at Riverside. (3 yes) (0 no)

Note: Mrs. Tuchman may be returning to Cape Elizabeth to live and would be eligible to purchase lots as a resident.

Request for Buy-Back of Lots

Jennifer Marshall, Section NI Lot #35

<u>Moved by Jessie Timberlake and Seconded by Sharon Smarc</u> to approve the buy back request of Jennifer Marshall for Section NI Lot #35 provided that further information and documentation is provided. The Committee wants to make certain Ms. Marshall is the closest heir having rights to the lot as her late husband Arlan Marshall purchased two lots and burying his late wife in one of the lots.
