## Recycling Bin:

Awaiting reply from public works and recycling committee on the bullets discussed at last month's meeting:

- The custodian is not happy with the design of the containers for 2 reasons: They catch water and are not designed for easy servicing (removing and replacing the plastic liners is difficult).
- o The public has expressed displeasure that trash container does not allow food. This is a misperception, Food is allowed! Signage will be modified to eliminate confusion.
- Public Works Dept. and the Recycling Committee will continue to monitor usage and effectiveness.
