Ordered the Cape Elizabeth Town Council amends Chapter 3 Personnel Code to comply with the current policy governing group life insurance for the Maine State Retirement System.

Sec. 3-2-9. Maine State Group Life Insurance.

Employees hired on a full time basis prior to July 1, 1990 were eligible to participate in the Maine State Group Life Insurance and Group Accidental Death and dismemberment plan provided they signed up for the Plan prior to July 1990. The Plan is offered through the Maine State Retirement System. Employee contributions are determined by the insurer. The life insurance coverage for an employee is the amount of the next round thousand dollars above the employee's pay. If death is accidental, the benefit is double the amount of coverage. Benefits are also payable in case of accidental loss of hands, feet or eyes. Upon retirement on pension, the employee's contribution ceases and the life insurance, but not the accidental death and dismemberment insurance, continues on a reducing basis at the rate of 15% per year, until it is reduced to 25% of the average amount, as determined by the Maine State Retirement System, or \$2,500 whichever is greater, which amount remains in force until death.

Ordered the Cape Elizabeth amends Chapter 3 Personnel Code to offer employees the option of participating in the Point of Service Plan offered by the Maine Municipal Employees Health Trust:

Section 3-2-10 Health Insurance.

The Town participates in the Maine Municipal Employees Health Trust (MMEHT) Comprehensive Plan. Employees have the option of choosing between the MMEHT Comprehensive Plan and the MMEHT Comprehensive Point of Service Plan. Employees shall have 95% of their applicable premium assumed by the Town and 5% paid for through payroll deductions. Coverage will begin on the first day of the next month after employment begins provided the MMEHT has approved all required forms. The Town of Cape Elizabeth reserves the right to participate in different medical insurance plans, with

comparable or better benefits, costs and claims service. The Town also reserves the right to change the health insurance plan if mandated to do so by the federal or state governments. Upon leaving Town employment, federal COBRA requirements permit employees to continue on the Town policy at employee expense. MMEHT will notify employees of their options.
