WHEREAS, some proposed, unaccepted ways may have public benefit to the Town either as public ways, pedestrian easements, utilities or for other purposes, in the future, the extent of which is difficult to determine;

WHEREFORE, the Town Council, pursuant to Title 23 M.R.S.A. Section 3032(2), hereby extends for a period of twenty (20) years all proposed, unaccepted ways within the Town of Cape Elizabeth except those proposed, unaccepted ways as shown on the maps attached hereto as Exhibit A and denoted as U-7-1, U-7-2, U-7-3, U-7-4, that portion of U-7-5 as sown on said map, U-29-2 and U-29-5.

The Town Clerk shall record an attested copy of this Order in the Cumberland County Registry of Deeds.
