PUBLIC HEARING SIGN ORDINANCE AMENDMENT RE: LIONS' FIELD ADVERTISING SIGNS

Intro - Councilor Jordan, Chairman Ordinance Committee

Chairman Groff opened the hearing to public comments at 7:58 PM.

Jim Rowe, 127 Oakhurst Road, President CE Little League - Mr. Rowe encouraged the Town Council to approve the amendment. The revenue from the signs will offset capital expenditures of the new field at Lions' Field, and subsidize the Little League program to keep it affordable.

After hearing no further comments, the hearing was closed at 8:01 PM.

ITEM #51-97/98 Moved by H. Berry and Seconded by H. Beyer
Be it ordained by the Town Council of the Town of Cape Elizabeth, Maine, in Town Council assembled to approve the following amendments to Chapter 21, Signs:

Sec. 21-2-2. Signs Permitted in All Zones with a Permit.

- (e) Sign area for each municipal facility shall not exceed a total of 100 sq. ft., except that signage in excess of 100 sq. ft. shall be allowed at the Lions Field Complex as provided for below. Notwithstanding the underlying zone, all types of signs shall be allowed for municipal facilities. The size of municipal facility signs shall be limited by the provisions of this ordinance. A permit for sign erection is required from the Code Enforcement Officer.
- (1) Lions Field Complex signage. Due to its relatively isolated setting and the existence of a dense buffer of natural vegetation, the Lions Field Complex may include advertising signage in addition to 100 sq. ft. of general signage. No more than 540 sq. ft. of advertising signage shall be allowed per field at the Lions Field Complex. Advertising signage shall be affixed to the inside of outfield fences and shall be made of a textile or plastic fabric material. Individual signs shall not exceed 3' x 6' and no more than 30 signs shall be allowed per field. Display of signs shall be limited to the period from the week before Little League Opening Day to the week after the end of post season play. The Cape Elizabeth Little League shall notify the Code Enforcement Officer at the beginning of the season prior to the placement of signs, although no permit shall be required.

Sec. 21-2-3 Permitted Signs in the TC, BA, BB, and BC Zones.

(a) Signs in the Business Signs Table are allowed with a permit in the <u>TC</u>, BA, BB and BC Zoning districts of the Zoning Ordinance. The total allowable sign area per establishment shall not exceed 75 sq. ft. except as provided elsewhere in this ordinance. Signs under this section which shall be erected for a period not to exceed 30 days shall be considered temporary and shall require a permit from the Code Enforcement Officer. No more than three (3) temporary signs per establishment per year shall be allowed.

Town Council Policy

It is the policy of the Town Council that the design, color and proper maintenance of advertising signage at the Lions Field Complex shall be the responsibility of the Cape Elizabeth Little League. Revenue generated by the advertising signs shall be retained by the Cape Elizabeth Little League (1) for its general program funding, and (2) to invest in the significant capital expense of a new field near the existing Lions Field.

WHEREFORE, the Town Council, without determining that the requested amendment <u>must</u> be sent to the Planning Board for its recommendation, and without prejudice to its right to hereafter determine the requested amendment is clearly contrary to the established Town policy expressed in the recently adopted Zoning Ordinance, does nonetheless refer the requested amendment to the Planning Board for its review and recommendations.
