Item #73 Consideration of a proposed amendment to the sewer user fees which would bill all customers based on a minimum monthly fee of \$26.50 and \$4.00 per hundred cubic feet of measured water usage for all use over 100 hundred cubic feet.

It is recommended a public hearing be set for March 15, 2000.
