Chairman Carson opened the hearing to public comments at 7:50PM.

Ordered the Cape Elizabeth Town Council approves the proposed amendment to the sewer user charge effective for the month beginning April 1, 2000 for all buildings within the Town of Cape Elizabeth which shall be connected to the public sanitary sewers of the Town on or before the last day of the month commencing February 1, 1996, and for each succeeding monthly period:

\$26.50 - Up to 100 cubic feet of monthly measured water usage\$4.00 - Each Additional 100 cubic feet, or fraction thereof, of monthly measured usage

Said Sewer Service charge shall be applied directly for each water meter in place as of December 31, 1999 and for every structure thereafter attached to the municipal sewer.

<u>Item # 88-99/00</u> **Public Hearing – Sewer User Fees for Cape Elizabeth School Department** Chairman Carson opened the hearing to public comments at 7:59PM. After hearing no comments, the hearing was closed at 7:59PM.

Ordered the Cape Elizabeth Town Council approves the sewer bill for the Cape Elizabeth School Department school buildings, \$63,000 annually for the fiscal year beginning July 1, 1999, \$53,600 for the fiscal year beginning July 1, 2000, and thereafter the school department sewer bill shall be based upon metered water usage. Beginning on July 1, 2000, the Donald Richards Community Pool and fitness center shall pay 10% of the overall sewer bill for the school buildings. Beginning on July 1, 2001, the pool sewer bill shall be based upon a meter measuring the pool and pool locker area water usage.

- 2. \$3,000 effective April 1, 2000, for each unit to be served by the municipal sewer system that did not pay the availability charge from March 1, 1988, to January 31, 1996. Effective January 1, 2006, the connection fees shall no longer provide for any credit for having paid the availability charge.
- 3. Said fees shall be paid prior to any connection to said system. (7 yes) (0 no)
