Item # 15

Action to consider the approval of a revised FY 2001 appropriation for the Department of Public Works.

The town manager recommends the appropriation for the Public Works Department for Fiscal Year 2001 be revised from \$795,852 to \$845,852. This is due primarily to winter and fuel related costs. \$20,000 of the increase is offset by a grant from the Federal Emergency Management Agency for the March snowstorms.

#### Item # 16

Action to consider the proposed final enactment of the state school subsidy. The Maine Legislature approved a state school subsidy to the Town of Cape Elizabeth in the amount of \$2,493,757. At the time the Fiscal Year 2002 general fund budget was adopted last month, the amount we believed we would be receiving was \$2,440,989 or a difference of \$52,768. The town manager recommends the \$52,768 be placed in a reserve fund for support of the Fiscal Year 2003 school budget. This year as the result of the Maine Legislature, we had an expected \$436,480 loss in state school subsidy reduced to a loss of only \$41,358. We have a grim outlook for the Maine Legislature to continue to provide the cushion to the extent that enabled this additional \$395,122.

#### Item # 17

Action on proposed lease renewal of Building #326 at Fort Williams Park to Drug Rehabilitation, Inc. (Day One). The five year lease provides for a monthly lease of \$2,520 indexed to the annual adjustment to the local property tax rate. The base amount in the first year represents a 20% increase from the final year of the expiring lease. The lessee continues to absorb utility costs etc.

#### Item # 18

Action on bids for the Broad Cove Road reconstruction project. The town manager recommends a bid award to Dearborn Brothers. Inc. based on the memorandum included in the town council packet. The proposed budget for the project also includes contingency and construction inspection.

#### Item # 19

Action to agree to accept a proposed deed rider in order to implement the affordable housing provisions for the Whale Back Ridge subdivision.

This is a revised agreement.

#### Adjournment

Following the Town Council Meeting, the Boards of the Thomas Jordan Trust and the Museum at Portland Head Light will meet briefly to conduct their annual elections of officers. The boards are composed of the members of the Town Council.

Recognition of Town Hall Centennial

Chairman Carson read the following:

The Cape Elizabeth Town Hall reaches the centennial of its dedication on June 19th. While other municipal buildings have seen great changes in recent years, the town hall remains a local

landmark whose exterior has changed little over recent decades. Citizens from 1901 would still recognize the Doric columns, the front porch, the cupola and much of the façade on Ocean House Road.

Cape Elizabeth had separated from South Portland in 1895 and soon thereafter a debate began on the necessity of having a Town Hall. In 1900, it was voted to build a new town hall and Portland architect Frederick A. Tompson drew up the plans for the sum of \$90.00. Land had been acquired from the Robinson family. William Murray and Son provided the low bid of \$4,005.19. Other expenses for grading, furnishings and out buildings brought the total expense up to \$5,002.43. The foundation and grading was provided by farmers from throughout the town under the supervision of Albert Hannaford. Hannaford also served on the building committee along with P.W. Harry and Charles Jordan, Michael and Frank Peabbles, C.E. Staples, a Mr. Pollard and William Murray.

The dedication ceremony according to the diary of Elizabeth Murray began with a prayer and music by the Bowery Beach Orchestra. It continued with a long speech from the Hon. William Henry Clifford and then the Rev. Mr. Lawton advised everyone to forget their differences and be proud of the new town hall. A letter was read from a General Cruft offering a bell for the Town Hall (it is now in the Spurwink Church). After a flag raising, a sextet sang the Star Spangled Banner, Yankee Doodle and America. The Portland Daily Press described the town hall as it was nearing completion as follows, "Taking it all in all it is a perfect country town house with which the people are much pleased.."

The town hall was greatly expanded in 1948 with the present Council chamber and wings added. After classrooms were abandoned in the early 1970's, the building was renovated in 1977 and 1978 with the School Superintendent's office moving upstairs. In 1995, an elevator was installed.

The building should continue to serve the town's office needs for many decades to come.

Councilor Henry N. Berry, III played on the piano, the Star Spangled Banner, Yankee Doodle and America. The same three songs that residents 100 years ago sang to celebrate the completion of their new town hall.

# Reports and Correspondence

Councilor Roberts thanked Robert Malley for placing the town line sign on Ocean House Road, which clarifies the new homes being built, are in South Portland.

Councilor Swift-Kayatta thanked town and school employees for their efforts during graduation at Fort Williams Park on June 10. She also recognized High School Principal Pete Dawson. Mr. Dawson has accepted an administrative position out of the country. Thanks to volunteers of Project Graduation.
