Ralph T. Gould Award - Presented by Chairman Swift-Kayatta to Gilbert S. Jordan

"Tonight it is my honor to present the Ralph T. Gould Award for 2001. This award, established in 1986, was named for the late Ralph Gould to recognize his community service and subsequently to recognize those who provide community service in the same spirit as Ralph Gould. This evening, we add someone who has given service to the Town of Cape Elizabeth in many capacities.

The 15th recipient of the Ralph T. Gould award is Gilbert S. Jordan.

Gillie Jordan is one of those citizens who step forward whenever there is a need. He was one of the founders of the Cape Elizabeth Rescue Unit. He has been a volunteer with the Cape Elizabeth Fire Department for over 38 years.

He served as Captain of Engine Two Company. He served on many truck committees, most notably the committee for the current ladder truck used by the fire department.

Gillie was the chairman of the Facilities 2000 Committee overseeing the planning for the new public works garage and

other improvements at the Gull Crest property. As head of this committee he also guided the committee to decisions to renovate the former public works garage into a new fire station and to construct a new police station. He has recently taken on the responsibility of chairing the Community Center Study Committee.

In addition to these quite public efforts, Gillie has also very quietly helped with the planting of flowers at the Town Hall and at the public safety building over the years. He not only has donated the flowers each year, but has also planted then with the help of his wife Barbara.

Gilbert Jordan is a person who dreams of what can be accomplished and then who sets out to see the dreams become reality. He truly has acted in the same spirit as Ralph Gould in placing Cape Elizabeth at the forefront of his priorities.

On behalf of the entire Town Council and all the citizens of Cape Elizabeth, it gives me great pleasure to present to Gilbert Jordan the year 2001 Ralph Gould Award."

Reports and Correspondence

Councilor Berry mentioned the efforts of the Conservation Commission regarding the purple loosestrife (a plant that is interfering with native plants and vegetation). Beetles have been brought in to eat the flowers on the purple loosestrife in an effort to control the spread.

Councilors Berry and McGinty met with Cumberland County Treasurer Diane Gurney regarding changes in the position of Treasurer. Councilors Berry and McGinty believe legislation to give the Cumberland County Budget Committee more than advisory power is necessary, as other counties.

Congratulations to the Maine Library Association. The Maine Civil Liberties Union will award its Roger Baldwin Award to the Maine Library Association at its annual celebration on October 25. The Maine

Civil Liberties Union will honor the Maine Library Association for the MLA's courageous stand opposing censorship in its latest guise: limitations on the Internet information that library patrons can access at library computer terminals. The MLA was the first named plaintiff in the national ACLU's current lawsuit challenging The Children's Internet Protection Act (CHIPA). CHIPA requires any library, which receives federal funds to block certain Internet materials. Library Director Jay Scherma is the President of the Maine Library Association.

Debra Lane gave the Town Council an update on Cape Elizabeth's participation in Rapid Renewal. The Town Council approved the program at the July 9, 2001 Town Council Meeting.
