The Cape Elizabeth Town Council will be meeting in workshop session on Monday, November 26, 2001 at 7:30 p.m. in the William H. Jordan Conference Room to review the report of the Community Center Planning Committee.

The committee is recommending a \$1.692 million renovation and site work at the Pond Cove Millworks building. This is a reduction of \$1.270 million from the October 9, 2001 plan estimate of \$2.962 million.

The Town Council had asked for a plan at a cost of \$1.25 million. With the potential sale of 1226 Shore Road (the current community center) and the estimated \$200,000 in proceeds being devoted to the new community center, the estimate is \$242,487 from the town council request.
