Ordered, the Cape Elizabeth Town Council, having held a public hearing on Monday, May 14, 2001, does hereby adopt the Municipal Budget for Fiscal Year 2002 with gross expenditures of \$22,494,278 and gross revenues of \$6,848,051 and with the amount of \$15,646,228 to be raised from taxation, and does further fix Thursday, October 4, 2001, and Thursday, April 4, 2002, as the dates upon each of which one-half of such tax is due and payable, with interest to accrue upon taxes due and unpaid after each such date at the rate of eleven and one half percent (11.5%) per annum. In accordance with 36 M.R.S.A. Section 506, the Tax Collector and Town Treasurer are authorized to accept prepayment or decline prepayment of taxes not yet committed or prior to any due date and pay no interest thereon. In accordance with 36 M.R.S.A. Section 506-A, a taxpayer who pays an amount accepted by the tax collector and town treasurer in excess of that finally assessed shall be repaid the amount of overpayment plus interest from the date of overpayment at the annual rate of 7.5% per annum.

In addition the State of Maine directly assumes the cost for the employer share of teacher retirement.

Ordered, the Cape Elizabeth Town Council hereby appropriates from the Foundation Allocation for school purposes the sum to be provided by the Maine Legislature and the Town of Cape Elizabeth raises as the local share of the Foundation Allocation the sum required as the local share by the Maine Legislature.

Ordered, the Cape Elizabeth Town Council hereby raises in additional local education funds under the provisions of 20-A MRSA, Sec 15614, the sum of \$14,275,651 less the amount provided by the State of Maine and less \$313,946, (\$14,275,651 minus the state subsidy minus \$313,946) with said amount total for schools from taxation not to exceed \$11,520,716.

Ordered, the Cape Elizabeth Town Council hereby authorizes the expenditure for the Fiscal Year beginning July 1, 2001, and ending on June 30, 2002, from the Foundation Allocation, the Debt Service Allocation, unexpended balances, local appropriations, State Subsidy and other receipts for the support of schools the sum of \$14,275,651.
