Sec. 13-7-4. Vehicle Travel Restriction. Within the School Complex, registered motor vehicles are restricted to the roadways. Vehicles are prohibited from utilizing Jordan Way for access to and egress from the School Complex except for emergency vehicles and or except in accordance with a traffic

plan approved in writing by the town manager for the purpose of relieving traffic entering the school complex. Snowmobiles on the school complex shall be restricted to those areas immediately adjacent to the Spurwink Marsh. and unregisteredmotorbikes, mopeds and minibikes are prohibited. Unregistered motor vehicles are prohibited on the School Complex.

An enactment clause is being prepared for consideration at the town council meeting.
