Town Clerk Coy reported that there is going to be a Special Referendum Election on June 10, 2003. It is for a \$60 million bond issue to stimulate economic growth and job creation through investments in research and development, municipal infrastructure and facilities, the Maine Farms for the Future Program and affordable housing, in anticipation of approximately \$134,150,000 in federal and private funds.

Town Manager McGovern thanked everyone for the successful election on May 6, 2003.

He recognized Harry Proudman, CETV coordinator, and the Yosua brothers for the great job they did for the Football Boosters Auction on May 3.

He updated everyone on the Route 77 paving this spring and the Revaluation process through the Assessor's office.

Mr. McGovern also announced that the Memorial Day parade and festivities will start at 9 a.m. at the corner of Fowler Road and Route 77. Jim Cox has done a wonderful job as coordinator.

Item # 114-02-03 Municipal, School, Community Services and County Budgets

Moved by M. Lynch and seconded by H. Berry

Ordered, the Cape Elizabeth Town Council, having held a public hearing on Monday, May 12, 2003, does hereby adopt the General Fund Budget for Fiscal Year 2004 with gross expenditures of \$24,330,000 and gross revenues of \$6,641,724 and with the amount of \$17,688,276 to be raised from taxation, and to fix Tuesday, October 7, 2003, and Tuesday, April 6, 2004, as the dates upon each of which one-half of such tax is due and payable, with interest to accrue upon taxes due and unpaid after each such date at the rate of seven percent (7.0%) per annum. In accordance with 36 M.R.S.A. Section 506, the Tax Collector and Town Treasurer are authorized to accept prepayment or decline prepayment of taxes not yet committed or prior to any due date and pay no interest thereon. In accordance with 36 M.R.S.A. Section 506-A, a taxpayer who pays an amount accepted by the tax collector and town treasurer in excess of that finally assessed shall be repaid the amount of overpayment plus interest from the date of overpayment at the minimum annual rate per annum set by the State of Maine.

Item # 123-02-03 Draft Vote Authorizing Addition to Pond Cove School

Chairman Roberts provided the opportunity for the following citizens to speak on the item:

Mary Townsend – 5 Pearl St. concerned on the school space and enrollment.

Kevin Kobel – 12 Waumbek Road – Stated that he believed that the new Municipal buildings were built without Residents' knowledge or approval, so why do the school projects all have to be approved and voted on?

Christopher Lynch – 880 Shore Road – questioned why the Kindergarten deferral to July was moved back to May.

At the request of Chairman Roberts, Marie Prager, Chairman of the School Board, reaffirmed the memo to the Town Council and School Board recommending the Town Council approve the building addition to Pond Cove at the May 12, 2003 meeting.

Ordered the Cape Elizabeth Town Council vote to table indefinitely the expenditure of up to \$1,475,000 for constructing and equipping a new Kindergarten facility at the Town's Pond Cove Elementary School and the issuance of up to \$1,475,000 in bonds to finance such expenditure.

Item # 124-02-03 Draft Vote Authoring Pond Cove School Addition after Referendum

Moved by A. Swift-Kayatta and seconded by H. Berry

Ordered the Cape Elizabeth Town Council authorize:

EXPENDITURE OF UP TO \$1,475,000 FOR CONSTRUCTING AND EQUIPPING A NEW KINDERGARTEN FACILITY AT THE TOWN'S POND COVE ELEMENTARY SCHOOL AND THE ISSUANCE OF UP TO \$1,475,000 IN BONDS TO FINANCE SUCH EXPENDITURE

VOTED.

That the Cape Elizabeth Town Council hereby authorizes the expenditure of up to \$1,475,000 for relocating the Town's public kindergarten facilities, including the constructing and equipping of a new kindergarten facility at the Town's Pond Cove Elementary School, and for costs and expenses related thereto.

VOTED:

Pursuant to the provisions of Section 5772 of Title 30-A of the Maine Revised Statutes and all other authority thereto enabling, and in order to provide funds for the school project authorized by the foregoing vote and the costs and expenses related thereto, the Town Council of the Town of Cape Elizabeth hereby authorizes the Treasurer to borrow on behalf of the Town up to \$1,475,000 in principal amount.

VOTED:

That in order to effect the borrowing heretofore authorized, the Treasurer be and hereby is authorized to prepare, issue and sell notes or bonds of the Town in the aggregate principal amount not to exceed \$1,475,000, such notes or bonds to be signed by the Treasurer, countersigned by the Chairman of the Town Council and attested by the Town Clerk.

VOTED:

The form, maturity, interest rate and other details of said notes or bonds shall be as determined by the Treasurer and the Chairman of the Town Council by their execution thereof, but shall have a final maturity not later than 20 years from date of issuance, and shall not be inconsistent with the provisions hereof. Such notes or bonds and any notes issued in anticipation thereof may be issued as callable notes or bonds in the discretion of the Treasurer and Chairman of the Town Council.

VOTED:

That the Treasurer and the Chairman of the Town Council are hereby authorized on behalf of the Town to borrow money in anticipation of the issuance of said notes or bonds by the issuance and sale of notes and renewal notes in anticipation thereof, such notes and renewal notes to be in such form, have such maturity and bear interest at such rate as may be approved by the Treasurer and Chairman of the Town Council by their execution thereof.

VOTED:

That the Chairman of the Town Council, the Treasurer and Clerk, and other proper officials of the Town be, and hereby are, authorized and empowered in its name and on its behalf, to do or cause to be done all such acts and things as may be deemed necessary or desirable in order to effect the issue and delivery of said bonds and notes hereinbefore authorized in the foregoing resolutions.

VOTED:

That the Town covenants and certifies that no part of the proceeds of the issue and sale of the notes and bonds authorized to be issued by the foregoing resolutions (including any notes and bonds in renewal thereof) shall be used, directly or indirectly, to acquire any securities or obligations, the acquisition of which would cause such notes or bonds to be "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended (the "Code").

VOTED:

That the Treasurer of the Town be authorized to covenant on behalf of the Town and for the benefit of the holders of the notes and bonds, that the Town will take whatever steps, and refrain from taking any action, as may be necessary or appropriate to ensure that interest on the notes and bonds will remain exempt from federal income taxes.

VOTED:

That said notes and bonds are hereby designated "qualified tax exempt obligations" under Section 265(b)(2) of the Code.

VOTED:

That this Bond Resolution shall constitute the Town's official declaration of intent for purposes of Section 1.150 of the Internal Revenue Regulations, and to the extent that any costs of the school facility project are paid by the Town from the general fund or other fund, such payments may be reimbursed from the proceeds of said notes or bonds.

VOTED:

That the notes and bonds authorized by this Bond Resolution may, if so determined by the Treasurer, be combined with any other notes or bonds duly authorized by the Town of Cape Elizabeth and together issued as a single bond issue in the aggregate amount of the notes and bonds so authorized.

VOTED:

That the question of incurring the expenditures and issuing the bonds and notes authorized by the foregoing votes be submitted to the voters of the Town of Cape Elizabeth in an advisory referendum election on November 4, 2003 and that the foregoing votes authorizing the expenditures and the issuance of bonds and notes shall not, without further vote of the Town Council, be effective unless approved by the voters in such referendum election.
