§ Eleanor Guare- 301 Fowler Road: Asked by resident Susan Long to present petition with over 100 signatures against the tower stating that the tower will only increase coverage in sparsely populated areas and not address the problem in Broad Cove and Fort Williams; it is in conflict with the Comprehensive Plan of 1993; it would have impact on significant wildlife habitat.

§ Seth Sprague- In behalf of the Sprague Corporation: is in favor of the project because of safety issues for the Fire and Police department; convinced of a community need; and the Sprague Corp. will get a financial benefit to offset the higher taxes and conserve their property.

§ Heidi Hansen- 313 Fowler Road: against the project stating the safety issues came up after the cellular people, and that residents on Fowler Road do not need the coverage.

§ Paul Woods, Jr.- 20 Running Tide Road: for the project stating that cell phones are a necessity and a vital part of this town, not only for public safety; a tower should also be considered at Fort Williams; people rely on cell phones and will rely on them more down the road.

§ Richard Berman- 1021 Shore Road: against the project stating the private businesses want the tower and the landowner wants the zone change-safety issues were an afterthought; keep the area rural and preserve the historical values.

§ Bill Frick- LLC International Corp. speaking for US Cellular: Easy to say-not in my backyard- supports the residents that comment on this issue; explained the who, where, what, when and why cell towers are constructed and needed.

§ Bill Hewitt- 113 Fowler Road: found LLC's speech informative, but overbearing.

§ Dennis Gallagher- 357 Fowler Road: stated that technology is changing rapidly and is concerned that this tower may be obsolete shortly.

§ Prekash Suman- 89 Starboard Drive: is a resident and works for LLC International; has been on this project design for almost a year; stated that this tower covers the maximum area coverage; Town will support higher rates of service for years to come; Every individual deserves the right to cellular service.

§ Schuyler Armstrong- 18 Avon Road: has no cell service at her home. The Fire Chief spoke at the last meeting stating that safety issues are front and center when you cannot get the service.

§ Elizabeth Skypeck- 14 Fenway Road: asked what happened to the issue in Shore Acres, and what did we do before cell phones?

§ Carl Dittrich- 500 Ocean House Road: against the project stating that we can use landline phones, and if necessary, are only a minute away from cell phone coverage.

§ Dave Dalessandri- 7 Susan Road: Why approve a new site

when one has been approved at the transfer station?

§ Bob Siegel- 17 Brook Road: against the project stating that without the service, it is inconvenient, but not life and death;will everyone get coverage with this?

§ Gail Parker- 317 Fowler Road: concerned because she has so many questions and what will it do to the rural character?

§ Tom Guare- 301 Fowler Road: against the project

§ Tom Carrellas- 297 Fowler Road: against the project; appreciates Mr. Sprague's comments and how he will be compensated compared to the people directly next to the tower.

§ Mark Stanfield- 329 Fowler Road- stated we do not have all the answers-needs more discussion; scenic area should be left alone per comprehensive plan; should have an independent engineering company do research.

§ Greg Davis- 235 Bowery Beach Road: against the project; it would be looming over his house, doesn't think we need it because we have 80% of coverage now.
