# Item # 62-04-05 Request from a citizen to amend the sewer service map to include 54 Shipwreck Cove

Dr. Paul Barresi, owner of 3 Oak Knoll Road and 54 Shipwreck Cove Road is requesting that these two properties be added to the sewer service area map. His home at 3 Oak Knoll Road is already connected to the sewer and the home on the opposite side of 52 Shipwreck Cove Road is already connected to the sewer. This would permit his property between the two connected properties to be connected to the municipal sewer.

# Item #63-04-05 Request to refer item to the Planning Board

A request has been received from the owner of a 7,981 square foot lot to amend the Zoning Ordinance to permit construction of single family homes on lots sized under 10,000 square feet in sewered areas. It is recommended that the issue of smaller building lot sizes in sewered areas be referred to the Planning Board.

# Item # 64-04-05 Request to adopt a policy relating to the general fund undesignated fund balance

DRAFT POLICY: The town council shall seek to maintain a general fund

undesignated fund balance of 8.33% of annual general fund operating revenues, which percentage is equivalent to revenues anticipated in an average one month period.

If the targeted undesignated fund balance is exceeded, 50% of any excess funds shall be used to reduce the tax commitment in the next budget to be considered by the town council. The remaining 50% shall be placed in a capital reserve fund to replace equipment and/or to undertake needed infrastructure improvements.

During any year when the undesignated fund balance is less than its target level, the town council shall attempt to increase, as a percentage of operating revenues, the undesignated fund balance. As long as the undesignated fund balance is below the target level, the undesignated fund balance shall not be used to support the annual budget or other capital needs if doing so will result in the undesignated fund balance being a lower percentage of operating revenues than in the previous fiscal year.

# Item # 64-04-05 Goddard Mansion Report

It is recommended that the town council acknowledge receipt of the Goddard Mansion report, authorize the immediate safety issues to be addressed using previously allocated funds from the Fort Williams Capital Fund, (no property tax dollars) and refer the report to a workshop for further discussion and review.

MacDuffie and Sheila G. Mayberry (MacDuffie/Mayberry") and described in a deed recorded in said Registry in Book 17676, Page 32; and on the south by said land of MacDuffie/Mayberry and of Pinansky.
- 2. Reference is made to an Agreement As To Mutual Restrictions and Covenants dated July, 2004, by and between Pinansky, owner of certain real property described in a deed recorded in said Registry in Book 16629, Page 326, and MacDuffie/Mayberry, owners of certain real property described in a deed recorded in said Registry in Book 17676, Page 32, regarding certain building restrictions and set-back requirements. - 6. Excepting and reserving from this vacation order with respect to Katahdin Road Extension is a pedestrian easement over the entire length and width of Katahdin Road Extension as shown on said Plan of Shore Acres together with the right to construct, repair, replace and utilize the same as a pedestrian trail for recreation access use and to construct such stairs, bridges, boardwalks and erosion control measures as the Town may deem necessary and advisable in its sole discretion; and
- 7. Excepting and reserving from this vacation order are any rights of the Portland Water District for the operation, maintenance, repairing and replacement of a waterline within Katahdin Road Extension and Overlook Lane.

Item #45-04-05 Resolution on Tax Cap Proposal

Moved by M. Lynch and Seconded by J. Roberts

Resolved, the Cape Elizabeth Town Council urges a "No" vote on the Palesky initiative because its statewide passage will result in chaos and confusion due to the initiative's unclear and likely unconstitutional language, a loss of decision making control at the municipal level, and substantial adverse impacts on the ability of towns and cities to provide adequate municipal and school services to their residents.

(6 Yes) (1 No) - J. McGinty opposed

Moved by M. Mowles and Seconded by J. McGinty

Resolved, the Cape Elizabeth Town Council pledges that if the Palesky initiative is defeated the Council will use 100% of any net additional revenue that the town receives from the state as the result of the June 2004 statewide school funding referendum, to reduce the property taxes of property owners in Cape Elizabeth. However, if the Palesky initiative is approved, any net additional revenue that the town receives from the state as the result of the June 2004 statewide school funding referendum will in whole or in part be utilized for maintaining existing school programs and services to mitigate the loss of property tax revenue.

Resolved, the currently elected members of the Cape Elizabeth Town Council individually commit themselves to limit spending in the next three years to a level not more than the rate of the consumer price index, with the exception of voter approved debt and an allowance for additional school enrollment and population growth.

Item # 46-04-05 Voter Ratification of Municipal Debt

The tax cap initiative on the November 2, 2004 ballot provides that the tax cap limit of 1% of valuation shall not apply to all debt approved by the voters prior to July 1, 1999 or to any bonded indebtedness for the acquisition or improvement of real or personal property approved on or after July 1, 1999 by 2/3rd of the vote cast by voters voting on the proposition in a general election. Cape Elizabeth citizens have approved debt a number of times, but as general elections are held only in November in even numbered years, it appears that the statewide vote within the Palesky initiative would remove the local decision impact of the prior votes. It is proposed to give Cape Elizabeth voters an opportunity to ratify all of our previously authorized debt so that it is outside the cap limit.

### TREASURER'S CERTIFICATE

The undersigned Treasurer of the Town of Cape Elizabeth hereby certifies:

- 1. The intent of this question is to ask whether the Town's already authorized and outstanding debt will be ratified and approved by the voters as an exemption to the proposed statewide tax cap. It does not authorize any new debt. Any debt already exempt from the statewide tax cap if enacted will remain exempt regardless of the outcome of the vote on this question.
- 2. The total amount of general obligation debt of the Town of Cape Elizabeth outstanding on June 30, 2004 was \$17,499,962
- 3. The total amount of general obligation debt (including any notes in anticipation thereof) of the Town of Cape Elizabeth authorized, but unissued, was \$9,450,000 on June 30, 2004 of which \$3,725,000 was issued in August 2004 and \$1,000,000 interest free is being issued in the Fall of 2004, as part of \$9,450,000 approved by the voters in a non-general election on November 4, 2003.
- 4. The interest cost associated with the Town's outstanding debt as of June 30, 2004 was \$5,642,099 to maturity, which would result in a total cost of principal, and interest to be paid at maturity of \$23,142,061. During the period July 1, 2004 to June 30, 2005, \$1,550,619 in principal is being retired and \$703,348 in interest is being paid. School debt of \$4,725,000 being issued in FY 2005 will incur an interest expense of \$1,438,570 to maturity. The remaining school debt authorization of \$4,725,000 approved by the voters on November 3, 2003 is anticipated to be issued in 2005.
- 5. The contingent and overlapping debt of the Town of Cape Elizabeth includes a \$670,875 share of the debt of Cumberland County, \$1,063,000 of the Portland Water District Wastewater Fund debt, \$1,775,384 of the Portland Water District Water Fund debt, \$2,630,980 of the Regional Waste Systems, Inc. Incinerator debt and \$246,233 of the Regional Waste Systems, Inc. Material Recycling Facility debt.

The foregoing represents an estimate of costs associated with the Town's already issued and outstanding debt and all authorized debt. Such estimates may change due to market conditions. The validity of the voters' ratification of this debt shall not be affected by any errors in the foregoing figures. The ratification by the voters is conclusive and the validity of the ratification of the Town's debt is not affected

by reason of any variance of actual costs from the figures provided above.
