Reports and Correspondence

Councilor Fritz wanted to report that the Boards and Commissions orientation last week was a great success. The turnout was great, and thanks to Debra Lane for organizing the event, everything went smoothly. Anything you want to know about the Boards and Commissions is on our website. Councilor Swift-Kayatta reported that the Council had their first finance committee meeting on January 22, 2004. The expenditure target for the Municipal side is 5.8%, and for the School side 8.1%, which includes the new building projects. Mr. McGovern also announced that the Carol Palesky petitions have been certified by the State, and that her proposition, if passed in the November election, will change Town government as we know it. It will reduce our Town's budget by 9 Million Dollars, and there would be challenging consequences.

Regulations for the taking of alewives shall be as follows:

A minimum unobstructed opening of two feet (2') shall be maintained at all times between the riverbank and the downstream end of the weir.

The maximum mesh size of wire, twine, or other material used in the weir shall not exceed one inch by one inch $(1" \times 1")$.

There shall be a 72-hour weekly closed season on alewives from sunrise each Thursday morning until sunrise the following Sunday morning. During the closed season, a natural unobstructed opening of shall be maintained in the upstream and downstream end of the trap to allow for the escape of spawning alewives and other migratory fish.

All migratory fish such as salmon, shad, or other species except alewives and blueback herring which enter the trap, shall be removed and allowed to pass upstream.

Fishing operations shall cease and all fishing gear obstructing the passage of fish shall be removed from the fishing waters not later than June 5.

The total landings in pounds or bushels and value of the catch shall be made available to the Maine Department of Marine Resources and/or National Marine Fisheries Service on request by these agencies.

The town manager shall grant harvesting rights with preference being given to commercial fishermen and to landowners abutting any stream where the harvesting is to occur. No one may enter upon the land of another for the purpose of harvesting alewives except with permission of the landowner.
