Item# 23-2007 Annual Malt, Vinous and Liquors Permits and

Special Amusement Permit for the Inn by the Sea Property.

Ordered that the Cape Elizabeth Town Council approve the Annual Malt, Vinous and Liquors Permits and Special Amusement Permit for the Inn by the Sea.

Item# 24-2007 Update on Hannaford Field Kids Turf Project.

MOTION: M. Lynch **SECOND:** A. Swift-Kayatta

VOTE: 7-0

Ordered, the Cape Elizabeth Town Council hereby authorizes the town manager to sign an agreement to have a monofilament tuft field installed at Hannaford Field subject to the following provisions:

- The town manager shall first receive a recommendation from the superintendent of schools recommending a specific vendor.
- Prior to signing the agreement, the town manager shall receive a certified check for 90% of the value of the contract.
- The balance of the 10% of the contract shall be received no later than June 27, 2007. No work shall be commenced on new improvements to the field which are not necessary to complete this phase of the work until the full 100% value of the contract is received by the town manager.
- The scoreboard installation cost shall be privately funded.
- Approximately \$9,000 in further engineering costs including construction administration shall be privately funded.
- The soccer goals and safety nets shall be funded by the Cape Elizabeth School Department (\$5,000) and by booster clubs (\$6,000).
- The Town Manager shall purchase, with Municipal funds, a sweeper and groomer from existing appropriations at an estimated cost of \$4,300.
- It is understood that Town of Cape Elizabeth shall comply with any required permits from the Maine Department of Environmental Protection regarding storm water treatment and detention and if this cost shall exceed \$20,000 then further Town Council approval shall be required. Up to \$20,000 may be expended from the existing appropriation in the roadway/drainage account.
- The installation of the field shall necessitate an annual maintenance agreement costing \$5,900 each year. Such funding shall be included in the town manager's recommended budget each year.
- No funding is provided for an additional fence of approximately 8' in height that may be advisable for security purposes and the superintendent of schools may include funding for such a fence in a future school budget.
- It is understood that total pledges now equal \$620,000 and the known costs of the privately funded aspects of the project to be paid with cash raised by the Kids Turf group now equals an estimated \$606,700.
- It is understood that the value of the top soil to be removed from the existing field is calculated in to the bid for the project so the top soil will therefore belong to the contractor doing the work.

Item# 25-2007

Proposed Acceptance of Blueberry Road, Fernwood Lane and Red Oak Drive, two open space parcels and drainage and pedestrian easements in the Blueberry Ridge Subdivision.

Councilor Rowe wanted to make it known that his company had a working relationship with Joseph Frustaci, the developer of Blueberry Ridge, and had supplied a great deal of sheetrock for this project and wanted to know if he should abstain from voting on this item. (See Attached)
