Item# 41-2007Request from Wyley Enterprises, LLC for a sewer service area
extension on Eastman Road to include Map R4 Lot 18

Manager McGovern gave a brief introduction about the project, noting that the developer, Joel Fitzpatrick, and the project manager from Sebago Technics Owens McCullough were in the audience for questions. He said that the planning board has not made a formal vote regarding the sewer yet; however, it was discussed at the last workshop and they unanimously support the proposal.

Owens McCullough gave a small presentation about the location of the parcel and what the proposed development would be. He stated that the parcel of land has been purchased by Mr. Fitzpatrick and that they have met with the Town Planner, the Planning Board and Bob Malley.

Councilor Dill asked when the neighbors would be notified of the project. Town Planner Maureen O'Meara said they already had been notified in February. They will also be notified several times throughout the development process. She also noted the potential for neighbors to be able to hook into this new sewer line. However, this is in very early talks and the cost for this has not been determined yet. The Town Manager noted that there would be no requirement for the neighbors to tie in, it would only be provided as an option for them.

Councilor Lynch added that if a resident was hooked up to sewer it would be less expensive for them and friendlier to the environment.

Ordered that the Cape Elizabeth Town Council approve the proposal for sewer extension on Eastman Road and on amendment to the sewer service area map and considers it in conformity with the current and the proposed comprehensive plan.

Councilor Rowe spoke about benches at Holman Field and said that an offer from his company to provide the concrete blocks still stands.

Manager McGovern said that private groups have had tremendous success in raising money the last few years in Town.
