Dill to amend its zoning ordinance for purposes of allowing a wind energy system for purposes of municipal use and amending the definitions in Sec. 19-1-3, paragraph 2 under the title Wind Energy System to read: A structure or structures that may include a wind turbine, a tower, footings, electrical infrastructure, and associated equipment and structures intended to produce electrical power primarily for consumption by the local government. SECOND: J. Rowe

VOTE: 6 in favor – 0 opposed.

MOTION: J. Rowe to refer further the residential windmill issue to Town Council workshop.

SECOND: S. Lennon

VOTE: 6 in favor – 0 opposed.

Public Hearing Proposed Fiscal Year 2009 School Budget

- D. Hillman, 22 Cranbrook Drive, described the outcome of local research he has conducted in relation to how residents feel about the school budget.
- W. Roos, 36 Kettle Cove Road, encouraged the passage of the school budget as presented.

T. Dunham, 12 Becky's Cove Road, expressed concern on how the increased budget limit could impact residents on fixed incomes and setting a spending precedence in forthcoming budget years.

Item # 97-2008 School Budget

MOTION: D. Backer to set the school budget validation vote for Tuesday, July 22, 2008. The polls shall be open at Cape Elizabeth High School from 7:00 a.m. prevailing time to 8:00 p.m. prevailing time and the warrant for said vote shall be signed by the Municipal Officers.

SECOND: A. Swift-Kayatta. VOTE: 6 in favor – 0 opposed.

MOTION: C. Dill to adopt the language set forth therein.

SECOND: S. Lennon.

Discussion: Manager McGovern did confirm at the request of Councilor Dill that the proposed budget does reflect a 6% spending increase.

VOTE: 5 in favor – 1 opposed (Rowe)

In accordance with the provisions of the school consolidation act, it is proposed to amend the FY 2009 budget adopted on May 27, 2008 in Items # 70-74-2008 to read:

A. Ordered, the Cape Elizabeth Town Council, having held a public hearing on Monday, May 12, 2008, and on Monday, July 14, 2008 does hereby adopt the General Fund Budget for Fiscal Year 2009 with gross expenditures of \$30,783,101 \$31,046,184 and gross revenues of \$7,819,002 and with the amount of \$22,964,099 \$23,227,182 to be raised from taxation, and to fix Thursday, October 2, 2008, and Thursday, April 2, 2009, as the dates upon each of which one-half of such tax is due and payable, with interest to accrue upon taxes due and unpaid after each such date at the rate of eleven percent (11.00%) per annum. In accordance with 36 M.R.S.A. Section 506, the Tax Collector and Town Treasurer are authorized to accept prepayment or decline prepayment of taxes not yet committed or prior to any due date and pay no interest thereon. In accordance with 36 M.R.S.A. Section 506-A, a taxpayer who pays an amount accepted by the tax collector and town treasurer in excess of that finally assessed shall be repaid the amount of overpayment plus interest from the date of overpayment at the minimum annual rate per annum set by the State of Maine.

- #1 VOTED: Cost Center Summary. That the Town of Cape Elizabeth appropriate \$8,830,527 \$8,916,350 for Regular Instruction; \$2,321,456 \$2,364,763 for Special Education; \$49,694 for Career and Technical Education; \$582,451 \$601,070 for Other Instruction; \$2,122,205 \$2,262,539 for Student and Staff Support; \$598,436 for System Administration; \$950,436 for School Administration; \$627,389 for Transportation; \$2,007,632 \$1,982,632 for Facilities Maintenance; \$1,565,811 for Debt Service; \$0 for All Other Expenditures.
- #2 VOTED: State/Local EPS Funding Allocation. That the Town of Cape Elizabeth appropriate \$14,581,012.39 for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and that the Town of Cape Elizabeth raise \$11,505,402.50 as the Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688.

Explanation: The Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that the Town must raise in order to receive the full amount of state dollars.

WOTED: Non-State Funded Debt Service. That the Town of Cape Elizabeth raise and appropriate \$1,565,811 for the annual payments on debt service previously approved by the legislative body for non-state-funded school construction projects, non-state funded portions of school construction projects and minor capital projects in addition to the funds appropriated as the local share of the Town's contribution to the total cost of funding public education from kindergarten to grade 12.

Explanation: Non-state-funded debt service is the amount of money needed for the annual payments on the Town's long-term debt for major capital school construction projects and minor capital renovation projects that are not approved for state subsidy. The bonding of this long-term debt was previously approved by the voters or other legislative body.

WOTED: Additional Local Funds. That the Town of Cape Elizabeth raise and appropriate \$3,139,011.61 \$3,402,094.61 in additional local funds, which exceeds the State's Essential Programs and Services funding model by \$2,761,807.17 \$3,024,890.17.

The School Board recommends an appropriation which exceeds the State Essential Program and Services model for the following reasons:

The state's funding model does not support all of the costs of the schools because it includes only those costs considered essential by the state Essential Programs and Services (EPS) model.

Explanation: The additional local funds are those locally raised funds over and above the Town's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual debt service payment on non-state-funded school construction projects and the non-state-funded portion of school construction projects and minor capital projects that will help achieve the Town's budget for educational programs.

- #5 VOTED: Total School Budget Summary. That the Town of Cape Elizabeth authorize the School Board to expend \$19,656,037 \$19,919,120 for the fiscal year beginning July 1, 2008 and ending June 30, 2009 from the Town's contributions to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools.
- WOTED: Adult Education. That the Town of Cape Elizabeth appropriate for Adult Education, the sum of \$203,808 and the Town of Cape Elizabeth raise as the local share, the sum of \$82,951; with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult education program.
- WOTED: Special Funds. That the town of Cape Elizabeth hereby appropriates, in addition to the school budget amounting to \$19,656,037 \$19,919,120 the sum of \$1,125,092, said amount being the estimated amount expected to be received as revenues from the school lunch program, CEEF Grants, Title IA, Title IIA, Title IID, Title IVA, Title V and Local Entitlement Funds. If the actual revenues shall be less than the appropriated funds, then the appropriation shall be lowered to an equivalent level.
- WOTED: Additional Unanticipated State School Subsidy. That the town of Cape Elizabeth will reduce the additional local appropriation raised pursuant to Maine Revised Statutes, Title 20-A, §15690(3) for public schooling by the amount of any unanticipated state general purpose aid received for the fiscal year beginning July 1, 2008 and ending June 30, 2009.

In addition the State of Maine directly assumes the cost for the employer share of teacher retirement. The estimated amount is \$1,998,000.

VOTED: The school budget validation vote shall be held on June 10, 2008 which is ten business days from the date of adoption of this budget excluding Saturdays and Sundays. The school budget validation vote shall be on Tuesday, July 22, 2008. The polls shall be open at Cape Elizabeth High School from 7:00 a.m. prevailing time to 8:00 p.m. prevailing
