Item# 67-2009 Request for Executive Session

Ordered the Cape Elizabeth Town Council enters into executive session at 8:25 p.m. in accordance with 1 MRSA §405 6 A, C, D and F to continue the annual evaluation of the town manager, to review the status of collective bargaining agreements, to discuss the potential acquisition of an easement for the greenbelt and to review a request for a property tax hardship abatement. The property acquisition matter relates to the potential acquisition of an easement, in cooperation with the Cape Elizabeth Land Trust, with funds that have previously been set aside for land acquisition. The land area involved abuts Great Pond and would provide legal access along the shoreline on dry land owned by Jodie Jordan.

The council will exit executive session and reenter public session to vote on the request for a property tax hardship abatement and acquisition of an easement. No vote is anticipated on the remaining two items.

Ordered the Cape Elizabeth Town Council authorizes the Town Manager to acquire an easement from Jodie Jordan, Patricia Jordan and the heirs of Alvin Jordan upon a strip of land near Great Pond which is approximately 1,334 feet in length and 15 feet wide. The Town Manager may accept the easement with such language as is approved by the Town Attorney and the language shall be substantially the same as in the draft purchase and sale agreement provided for the March 9, 2009 Town Council meeting. The purchase price of the easement is \$53,970 with a donation toward the purchase amounting to \$25,000 to be received from the Cape Elizabeth Land Trust. The \$25,000 donation is hereby accepted and shall be credited to the Cape Elizabeth Land Acquisition Fund. The Town Manager, upon receipt of the CELT donation, may expend from the Land Acquisition Fund up to \$53,970 for the purchase of the easement and not to exceed \$3,000 for the Town's legal fees and other expenses. The net cost to the Land Acquisition Fund is therefore not to exceed \$31,970 leaving a remaining balance in the Land Acquisition Fund of approximately \$175,000. (6 yes) (0 no)
