Field usage has been scheduled as follows:

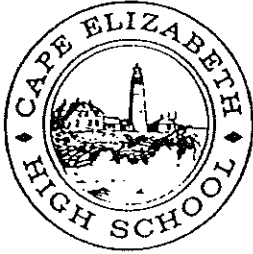

Dear Town Council Members and Michael McGovern,

The TD Banknorth Beach To Beacon 10k would like to formally request Saturday, August 7, 2010 as the date for the 13th Annual Beach To Beacon Road Race.

The race plan is to accept approximately 7,000 entries. This number includes 600 guaranteed entries for Cape Elizabeth residents, 200 guaranteed entries to runners who have run all twelve previous Beach To Beacon races, 4,000 entries through an online registration process (opens March 13th at 8am), and then an additional 1,500 through a lottery process with the drawing scheduled for March 20th. As in the past, approximately 700 entries are distributed to sponsors, charities, and elites/VIPs' between April and June. Historically, the race has experienced a consistent attrition rates in the 15-20% range. As a result, we expect approximately 6,000 runners on race day.

Thank you in advance for your consideration of this request and for your enthusiastic support of our event since 1998!
