# Planning Board Recommendation to the Town Council

TO: Cape Elizabeth Town Council

FROM: Planning Board DATE: March 29, 2011

RE: Roosters regulation referral

#### Introduction

At the August 9, 2010 meeting, the Town Council referred to the Planning Board "a suggestion that the Town should consider the status of roosters in Cape Elizabeth."

## Planning Board Process

The Planning Board held four workshops where the regulation of roosters was discussed (October 5, 2010, November 2, 2010, January 4, 2011 and February 1, 2011) and held two public hearings (December 21, 2010 and March 17, 2011).

## Public Participation

Comments from the public were forwarded from the Town Council and were also received in writing as part of workshops, in presentations from the Cape Farm Alliance as expert advise at workshops, and in testimony at the public hearings. Public comments included:

#### Recommendation

The Planning Board did draft amendments to the Zoning Ordinance that would have required a minimum of 40,000 sq. ft. to keep a rooster, which would have had the effect of prohibiting roosters in the most compact neighborhoods. At the March 17, 2011 Planning Board meeting, a recommendation supporting these amendments failed to pass with a vote of 2-3-1 (abstention).

While the Planning Board agreed that ordinance changes are needed to address noise, they did not support amendments to the Zoning Ordinance, in part because noise can be a problem in any neighborhood regardless of lot size.

At the March 17, 2011 meeting, the Planning Board voted (4-1-1 abstain) to recommend the following:

BE IT ORDERED that the Planning Board recommends that the disruption of the peaceful quiet and enjoyment of property that may be caused by roosters may be more appropriately addressed with amendments to Sec. 12-1-1, Disturbing the Peace, and Sec. 7-1-4, Dog Ordinance.
