IN THE TOWN OF CAPE ELIZABETH, MAINE

Spurwink Ave – approximately 565' Southerly of Starboard Dr, one pole

THIS APPLICATION IS BEING SUBMITTED WITHOUT PUBLIC NOTICE BY PUBLICATION

Said poles to be erected substantially in accordance with the plan filed herewith marked FairPoint No. 245211, dated June 20, 2011 and shall be of wood or other suitable material, and the cables and wires shall be run at the height of not less than 18 feet from the ground at highway crossings and not less than 15 feet from the ground elsewhere for electric cables and wires, and (or) not less than 8 feet elsewhere for telephone cables and wires. All cables and wires to be maintained in accordance with standards of the National Safety Code.

To the Town Councilors Cape Elizabeth, Maine

ORDERED: That NORTHERN NEW ENGLAND TELEPHONE OPERATIONS, LLC and CENTRAL MAINE POWER COMPANY be and are hereby authorized and permitted to erect and maintain poles and cables and wires to be placed thereon, together with such sustaining, supporting and protecting fixtures as said <u>companies</u> may deem requisite, in, along, upon and across the public streets and highways of said <u>Town of Cape Elizabeth</u> as hereinafter designated, as requested in application of said <u>companies</u> dated the <u>28th</u> day of <u>June</u>, <u>2011</u>.

All construction under this permit shall be in accordance with the following specifications:

The poles shall be located between the vehicular traveled section of the way and the limits of the highway shall be set firmly in the ground, substantially at locations indicated upon the plan marked FairPoint No. 245211 dated June 20, 2011 filed with said application, and shall be of wood or other suitable material, and the cables and wires shall be run at the height of not less than 18 feet from the ground at highway crossings and not less than 15 feet from the ground elsewhere for electric cables and wires and-or not less than 8 feet elsewhere for telephone cables and wires.

All cables and wires to be maintained in accordance with standards of the National Electrical Safety Code.

Following are the public streets and highways above referred to:

Spurwink Ave – From approximately 565' Southerly of Starboard Dr, one pole
