#### **Town Manager's Monthly Report**

Mr. McGovern provided a written report of paving and drainage projects for this year. Thank you to Bob Malley, Director of Public Works for his work coordinating these projects.

#### **Review of Draft Minutes of Previous Meetings – August 11, 2014 Town Council Meeting**

Moved by Katharine N. Ray and Seconded by James T. Walsh ORDERED, the Cape Elizabeth Town Council approves the minutes of the meeting held August 11, 2014 as presented. (7 yes) (0 no)

#### Item # 115 Update from the Firing Range Committee

Chairman Sullivan opened the item for public comments.

Edward Nadeau, 9 Apple Tree Lane stated people have the right to guns and people have the right to peace and quiet. Mr. Nadeau is opposed to granting the exception and requests a noise and safety assessment.

Eric Frehm, Yarmouth asked what does the town council plan to use for a noise standard.

James Richard, 9 Cross Hill Road is opposed to granting the exception and requests a safety inspection.

John Baldwin, 47 Cross Hill Road is opposed to granting the exception and encouraged additional time for the two groups to meeting and find "middle ground."

Tammy Walter, 1095 Sawyer Road, President of the Spurwink Rod & Gun Club Ms Walter encouraged the council to pass the exception so that the club can begin to make improvements. She also stated the safety inspection has been delivered.

Ralph Romano, 12 Tiger Lily Lane stated the provisions of the new ordinance makes a club "go around in circles;" the club needs to work toward shot containment, can't get building permit without license, and need license for a permit. The oversight in the ordinance needs to be addressed. The club should be given "a reasonable chance to perform." The town should be responsible for a safety assessment.

Cathy Kline, 66 Cross Hill Road, Member Firing Range Committee

Ms Kline said she didn't believe the neighbors meant to "get in the way" of the grant to the state. The neighbors are concerned about shot containment and opening the club to the public.

Richard Moran, 62 Cross Hill Road asked the council what is the "improved" outcome if the exception is granted.

Intro - Councilor Wagner, Chairman Firing Range Committee

The genesis of the request for exception is a timing issue, an attempt to commence construction this fall if the firing range committee deems it appropriate.

The ordinance requires a registration and application process. The ordinance permits the town council to grant exceptions on the basis of hardship and allows phased applications.

## Moved by James R. Wagner and Seconded by David S. Sherman, Jr.

ORDERED, the Cape Elizabeth Town Council approves the recommendation of the Firing Range Committee that the Town Council grant an exception to the Spurwink Rod & Gun Club pursuant to Article XIII Sec. 24-13-1, as follows: Notwithstanding Article IX, Sec. 24-9-1 the Firing Range Committee, in its discretion, has the authority to grant extensions to a firing range in order for such firing range to complete registration.

Pursuant to Sec. 24-13-1 Exceptions are required in this individual case;

- 1) Result in hardship
- 2) The hardship results from an application of the Ordinance of which the goal is shot containment

ORDERED, the Cape Elizabeth Town Council pursuant to Sec. 24-13-1 and Sec. 24-13-2 grants the exception to the Spurwink Rod & Gun Club as follows;

- 1) Result in hardship
- 2) The hardship results from an application of the Ordinance of which the goal is shot containment
- 3) The hardship related specifically to the Spurwink Rod & Gun Club which predates the adoption of the ordinance

Notwithstanding Article VIII, Sec. 24-8-1, the Code Enforcement Officer may approve grading, building, or other improvement permits, prior to the submission of a complete application and approval of a license if the Spurwink Rod & Gun Club provides access at reasonable times for a range safety evaluation to be performed at the request and expense of the Town of Cape Elizabeth. (7 yes) (0 no)

It was a consensus of the town council to take Item ##117 and 122 out of order.

## Item # 117 Use of Facilities Report

Intro – Chairman Sullivan Presentation – Greg Marles, Director of Facilities and Transportation

Mr. Marles provided a year's worth of data, tracking the number of reservations for 7 buildings (town and school). The data excludes the use of fields.

There were a total of 8491 reservations, a monthly average of 771.

No action was taken.

#### Item # 122 Roosters

Chairman Sullivan opened the item for public comments.

Crystal Kennedy, 17 Farm Hill Road, Owner of "Elvis" the Rooster The Kennedy's have "taken measures to appease the neighbors" who complain about the crowing from

Elvis including letting him out later in the morning and insulating the coop.

Joe Gaja, 15 Farm Hill Road has chickens and gave away a rooster. The homes on Farm Hill Road are close and the crowing noise is a nuisance. Roosters should be banned on small lots.

Patrick Kennedy, 17 Farm Hill Road, Owner of "Elvis" the Rooster

The Kennedy's have "taken measures to appease the neighbors" who complain about the crowing from Elvis including letting him out later in the morning and insulating the coop. Elvis has quieted down during the day.
