Item # 49-2015 Proposed Amendments to the Land Use Provisions of the Subdivision Ordinance and the Zoning Ordinance

Present – Maureen O'Meara, Town Planner Intro – Peter Curry, Chairman Planning Board

Public Comments

Christopher Straw, 597 Shore Road asked the town council to read the changes in detail and to strike the provisions to allow the planning board to waive set back requirements and the provision "unit as a unit."

Tony Owens, 19 Sea View Avenue referenced the 2005 survey in which a majority positively responded to open space, preserving the rural character and farm land and least important were changing the variety of housing, improvements to the town center, and attracting commercial development. 10 years after the last survey it's worth asking residents if they have changed their minds about multiplex housing.

Sara Lennon, 54 Cranbrook Drive said the town council needs to "take a mile high look, step back and ask what this action would look like on the ground." What do the citizens want? So far the town planner has "headed" several committees dealing with land use and it's time for a variety of viewpoints from not only the town council but from citizens. The item should be referred to a council workshop before another subcommittee.

Paul Seidman, 21 Oakview Drive asked what the "detailed consequences are by turning these recommendations into law?" Do the citizens agree with the multiplex recommendations? The review should "stop now or put up to a citizen vote."

Richard Gilbane, 226 Bowery Beach Road has worked on multi-residential projects and often lives in the midst of them. His advice is "don't do it." "Don't fall into the peer pressure because they have it, we need it. Keep the best that we have."

Suzanne McGinn, 1180 Shore Road referred back to the 2005 citizen survey in which residents favored protecting and preserving ponds, wooded areas, open space and rural character and disagreed with multi-unit buildings. With the proposed density bonus "the developer is getting a lot for nothing." Concerned about the density bonus on farm land. The item should not be referred to the ordinance committee. The town should take another survey to see if sentiments have changed and update the comprehensive plan.

Elizabeth Goodspeed, 59 Belfield Road "feels bad for people not protected by an HOA." Concerned about the density bonus which developers could build on agriculture land and receive "a lot of extra benefits with little in return." Each unit should count as one unit. The proposals are "so far off from what the 2005 results showed" the process should be slowed down for further discussion and take another survey.

Mary Townsend, 5 Pearl Street asked several questions including process. Why are changes being proposed now? If it's a plan not encouraging growth why are bonuses being proposed? Why is the size of buildings being increased? What is the harm in sending this to council workshop instead of ordinance committee?

ORDERED, the Cape Elizabeth Town Council thanks the planning board for its report and refers to a town council workshop the set of proposed amendments to the land use provisions of the subdivision ordinance arising from the 2007 Comprehensive Plan. (7 yes) (0 no)
