#### **Town Council Reports and Correspondence**

Councilor Sullivan thanked the volunteers and staff for a successful Night at the Light sponsored by the town for the 250<sup>th</sup> Anniversary celebration. The Solid Waste and Recycling Long Range Planning Committee report will be completed by the end of the month.

## **Update from Appointments Committee on Citizen Engagement Activities – Councilor MacAuslan, Chairman Appointments Committee**

The appointments committee on behalf of the town council is organizing a forum on Thursday, September 17 at the Middle School beginning at 7:00 p.m. This event provides an opportunity for the town council to reach out to citizens to obtain feedback and encourage public participation as it relates to community goals. #### Citizen Opportunity for Discussion of Items Not on the Agenda

Paul Seidman, 21 Oak View Drive addressed the upcoming discussion of a new village green multiplex project. "A critical step has been bypassed" which is clarifying the public benefit. The public rejected a plan two years ago which would require a change to the wetlands ordinance and with the new plan the public feeling remains true. Concerned with the change of language from a green and gathering place to multiplex.

Councilor Walsh objected to the statement of the wetland issue; it hasn't been a public issue yet.

#### Town Manager's Monthly Report - Michael K. McGovern

Matthew Sturgis, Town Assessor is completing the tax commitment for fiscal year 2016. Tax bills will in the mail by the end of next week. State school subsidy that Cape Elizabeth will receive is higher than anticipated. In the budget adoption is an understanding that additional school funding will go toward the reduction of taxes. As a result of higher state school subsidy, the originally estimated tax increase of \$.34 per thousand is reduced to \$.08 per thousand or 1/2 of 1%.

Tammy Walter, 1095 Sawyer Road and President of the Spurwink Rod and Gun Club thanked everyone for their support. "This set back has made the club stronger." The goal is to be safe.

Mark Mayone, Past President Spurwink Rod and Gun Club said although I don't agree with all of the report "the range evaluation will make us stronger."

Eric Stephanus, 2 Tiger Lily Lane commended the town council for the "fact-based" report. There is now an opportunity to look at the facts.

The two units could be sold to non-qualified buyers at market rates with any excess over \$395,022 for each unit to be provided to the town for other affordable housing. (6 yes) (0 no)

#### Item # 102-2015 Demolition of Bleachers at Fort Williams Park
