- ❖ Forums Several forums were held throughout the year targeting specific topics of interest. Perhaps citizens' questions and concerns were the same topics.
- ❖ With the various outreach efforts, meetings and committee work are citizens more informed throughout the year?
- Overall are citizens satisfied with the direction and decisions of the council?

Next Steps

What type of forums should be held? Should topic specific forums be held in place of general sessions?

Councilor Garvin expressed concern that if only topic specific forums are held, the council will loose input from citizens on other matters.

Councilor Lennon said dialogue with citizens should continue.

Councilor Garvin will report from the committee to the council at the 10/5 council meeting and suggest a workshop in 2017 to review suggestions and action for council communication and citizen input/feedback.
