Town Council Reports and Correspondence

Councilor Grennon, Ordinance Committee Chairman announced the next meeting of the ordinance committee on Tuesday, 4/11, 12-1:30 p.m. in the lower level conference room of town hall. Items to be discussed include shooting range ordinance technical amendments and the legalization of marijuana and the possible implications.

Councilor Penelope Jordan, member of the comprehensive plan committee updated citizens on the progress of the committee. A consultant to assist with public participation has been selected. The committee will also hire a public opinion consultant to assist for example with a survey. Citizens are encouraged to follow the committee's work and provide input and suggestions.

Chairman Garvin announced the Spurwink School Reuse Committee will meet again soon to continue the discussion of the possible use(s) for the building.

Finance Committee Report

Councilor Sullivan, Finance Committee Chairman reviewed the dashboard. A notable difference in revenue is the receipt of +\$140,000 or \$10,000 less than projected for the cable franchise fee. The fee is based on the cable company's gross annual revenue. Mr. Sturgis continues to follow up with Charter Communications to obtain an explanation of the reduced revenue and confirm whether more funds are due to the town.

Town Manager's Report April 10, 2017

The past month was very busy, with the budget being one of the primary focuses of the month, with two budget workshops being held March 21 and 22nd. The end result to this point is a municipal budget with a 1.4% increase in spending, and a 2.5% net increase, or an \$0.11 increase in the tax rate for municipal services. This would equate to a \$33 increase for a \$300,000 home.

The next budget related item is a workshop with the School Board on April 25th, when the Council and School Board meet to receive and review the school budget.

On March 24th I had the opportunity to attend the Manager's Interchange in Bangor. The program was specifically centered on the legalization of marijuana and the impacts and changes coming forward. The keynote speaker was the former manager of Frisco, Colorado. There were also speakers related directly to the legal questions and issues that towns will face with their ordinances. I am planning on sharing with the Ordinance Review Committee.

On April 3 the second half property tax bills were due, and in between March 30 and April 4 \$11,079,000 was collected. At the present time the Town has collected 96% of the original property tax commitment of \$29.6 million dollars. My appreciation goes to Debra Lane and her staff in the tax collections department.

Today, Community Services received delivery of their new mini bus. This new bus has capacity for 14 riders, is handicapped accessible, and will be a great benefit to senior programming and small group trips.

On April 29, 2017, residents will be allowed to bring in their unused and unwanted prescriptions and over-the-counter medications to the Cape Elizabeth Police Department from 10:00AM-2:00PM for disposal. Residents should take advantage of this opportunity to clean their medicine cabinets and dispose of the unwanted medications in a safe and environmentally friendly manner. Harbors Committee Charge

Committee Purpose

The Town of Cape Elizabeth last conducted a major review of its harbors in the late 1980's with nearly 30 years having passed since the last review of how our coastal water resources are serving our fishing, aquaculture and recreational boating needs, it is an opportune time to review issues relating to our harbors.

The committee shall:

- Review the Town's Coastal Waters and Harbor Ordinance and recommend any changes it deems desirable to the town council.
- Meet with state officials to determine options for boat access in the Kettle Cove/Crescent Beach State Park area and develop a long range plan for access.
- Update the maps utilized by the harbormaster showing potential locations for moorings.
- Inventory public water access.
- Assist the comprehensive plan committee with the marine resources section of the comprehensive plan.
- Consider such other related matters as the town council may request.

Committee Structure

The Harbors Committee shall consist of five persons. Two members shall be members of the town council chosen by the council. The town council, following a recommendation from the appointments committee, shall appoint three citizens. The committee shall appoint its own chair.

Committee Resources

Funds for the committee's work in the amount of \$15,000 are hereby appropriated from the unassigned fund balance. This shall fund a consultant to work with the committee who has expertise in issues relating to municipal harbors and boat access and shall fund expenses for mapping.

Committee Timeline

The committee shall first meet after January 2017 after appointments have been completed. The committee will complete its work with a report to the Town Council by December 31, 2017.
