### Item #96-2018 The Good Table – Liquor License Renewal

Intro - Mr. Sturgis

Councilors Caitlin and Penelope Jordan disclosed that they both sell agricultural goods to The Good Table, no objection was raised.

Moved by Penelope A. Jordan and Seconded by Sara W. Lennon ORDERED, The Cape Elizabeth Town Council approves the renewal malt, spirituous and vinous liquor license for The Good Table located at 527 Ocean House Road as presented. (7-yes)(0-no)

### Item #97- 2018 Request for Fund Raising – Pond Cove Playground

### **Opportunity for Public Comment**

Erin Taylor, 15 Roundabout Lane. Mrs. Taylor is a school nurse at Pond Cove Elementary and presented the reasons for this request, noting that the proposed funding for the playground reconstruction was removed from the past two school budgets. There are concerns about the age and safety of the playground structures, and they will need replacement. There is also the desire to provide more grassed play area. The desire is to raise funds outside of the budget process to accomplish this project.

Mr. Sturgis explained the reason for the request is that the administrative code of the Town requires approval by the council as the council is authorized to receive gifts on behalf of the Town.

Moved by Valerie A. Randall and Seconded by Penelope A. Jordan ORDERED, the Cape Elizabeth Town Council approves the request of Pond Cove School to fundraise to improve the playground at Pond Cove Elementary School. (7 yes) (0 no)

### Item #98-2018 Discussion on Implementing a Pay/Display Parking System at Fort Williams Park

### **Opportunity for Public Comment**

Jerry Kneller, 18 Ivie Road, commented on the Town needing solid revenue generating ideas at Fort Williams Park. The Town should optimize all revenue opportunities at Fort Williams.

Bob Hansen, 17 Ivie Road, commented that taxes are a significant burden and the Town needs to explore all revenue options and Fort Williams Park is the best opportunity. Surrounding parks all charge, such as the State parks and parks in Scarborough.

Jim Walsh, 23 Rock Crest Drive, commented that stewardship of the park is critical and parking revenue would greatly assist this effort. Mr. Walsh cited the challenges faced by the increasing volume of visitors. Additionally, the Fort Williams Park Committee supports the pay / display option. The current revenues generated by the park have been reviewed with recommended changes.

Mr. Sturgis provided an introduction to the item and explained why the item was placed on the agenda, as direction is needed from the council if the desire to proceed is held by the majority of the council. Mr. Sturgis also provided answers to prior questions raised by the council on the potential for renting units, leasing units, or purchasing pay display units. The greater challenge is not installation of the actual units, but of the policy question of pay / display parking at the Park.
