**Roll Call by the Town Clerk** 

All members of the town council were present except for Councilor Penelope Jordan.

### **Town Council Reports and Correspondence**

Chairman Sullivan thanked Debra Lane and the election staff for their work during the June 12 primary and school budget elections.

Councilor Lennon provided an update on the comprehensive plan committee. The committee is currently reviewing the land use chapter. The final public forum will be held in October – date to be determined.

Councilor Garvin spoke about contamination in the silver bullets. Approximately one-half of the silver bullets pulled from the town hall location are contaminated with materials that are not recyclable. ecomaine is not charging communities however that could change. Residents are urged to review the list of recyclable materials and for more information download the app from ecomaine.

## **Finance Committee Report**

Councilor Garvin, finance committee chairman and Mr. Sturgis reviewed the dashboard.

## Citizen Opportunity for Discussion of Items Not on the Agenda

Rebecca Little, 4 South Street read portions of the document emailed to the town council entitled, "Petition to the Cape Elizabeth Town Council to Prevent Traffic From Entering Our Private Roads From the Public Road and to Support the Reinstallation of Our Private Gate."

Julie Munz, 5 South Street stated I am here for a personal safety issue for my 7-year-old son who has severe epilepsy. The home was purchased on a dead end street for his protection. The gate provides environmental control and limits traffic; it never should have come down. Requests the town council to protect us and put reinstallation of the gate on the agenda.

Josh Nappi, 7 Stephenson Street supports reinstallation of the gate.

Henry Steinberg, 13 Hunts Point Road referred to a letter he sent to the town council stating removal of the gate will endanger the child. He believes the wrong decision was made by the planning board. Planning board, town council and zoning board are not professional board members and they generally go with what they consider is advice form the experts. The town council should consider an ombudsman in helping to resolve the matter.

Jim Fisher, Northeast Civil Solutions has been asked by a group of individuals who live on South Street to address the council. The biggest issue for the residents of South Street is until litigation is settled that a gate or chain with a Knox box be placed to restrict public vehicular traffic. Requests the town council to put the issue of the reinstallation of the gate on the agenda.

Marisa Ihara, 2 Stephenson Street has two young children (5 & 7) and is concerned about the increase in traffic since the gate has come down. Supports reinstallation of the gate.

Jessika Matheis, 2 Stephenson Street has two young children (5 & &) and with the gate being down the 7-year-old is no longer allowed to ride her bike with her friends within the neighborhood because of the severe increase in traffic and no sidewalks or shoulders. Supports reinstallation of the gate.

Chairman Sullivan stated because of pending litigation the councilors will not be commenting.

John Wall, Monaghan Leahy provided an overview of the pending litigation of the planning board's decision relating to the 8 Aster Lane project. It is Mr. Wall's understanding the parties involved may be trying to resolve the issue. Mr. Wall stated the town should let the court process continue.

#### **Town Manager's Monthly Report**

The new fiscal year began on July 1. The Town Office was closed on the afternoon of June 29, and this allowed the business office and staff to perform their year-end closing duties, which was very successful and allowed the operations to open without any challenges July 2. I want to extend my appreciation to the tax office and business office for their efforts in a successful year end and beginning.

As the fiscal year concluded it is also important to note that the Town committed \$30.5 million dollars in property taxes, and as of this morning had collected all but just over \$70,000. This is from roughly 4,500 properties in Cape Elizabeth. I would like to extend an appreciation to Debra Lane and her tax office staff for their excellent efforts in processing this incredible volume, and to the tax payers for their diligence as well.

Over the past few months the news has featured stories on the collapsing recycled materials market, as China has tightened its standards on what is acceptable or not. This changing market has driven ecomaine to perform a higher level of scrutiny on what is received in single stream recycling and in turn it is informing member towns of the level of contamination in their recycled materials. Contamination is items in the recycling that are not considered recyclable to the market. This would include plastic bags, metals, household waste, and other materials. We have received our data on contamination and these reports bring good and bad news. The good news is that recycled materials at the recycling center generally run from 0 to 5 percent contamination, with the primary contaminant there being plastic bags. The bad news is that the silver bullets behind Town Hall show consistent contamination in the 10 to 20 plus percent range. The recent report indicated such items as metal yard décor, tarps, and two wake boards. Cape Elizabeth is not the only community facing challenges in the unmonitored recycling drop offs, as other towns face similar challenges. I would like to request that people who do chose to recycle at the silver bullets behind Town Hall use them for recycling only and not for other forms of waste.

At the present time the Town is not being charged for contaminated recycling loads as we are an owner-member community of ecomaine, while other towns are being assessed a per ton fee based on levels of contamination. Eventually this non-fee relationship will change if the contamination trend continues and the recycling market does not improve. Some steps that can help us improve are to not recycle plastic bags, and if you do store recyclables in plastic bags, please empty the contents as recycling and then dispose of the bags as household waste. This is a changing environment and many people are attempting to do their best by recycling items that no longer have a home, so if you do have any question or doubt if an item is recyclable, it is best to dispose of as household waste.

On a final note, I would like to recognize and congratulate Community Services Director Kathy Raftice and Library Director Kyle Neugebauer on completion of the leadership academy recently completed at SMCC. This was a seven-week professional development course that was attended by staff members from South Portland, Cumberland County Government, Yarmouth, Scarborough, Falmouth, and other surrounding communities.

Tom Ward, 611 Shore Road stated Cliff House Beach has become like a dog park. The sign should reflect the current ordinance requiring dogs on leash within groomed or maintained municipal property. Recommends reviewing what other towns have done to prevent dogs on the beach during peak hours.

John Holdridge, 2 Glen Avenue (5 years) said he has noticed a change in the number of people visiting the beach. Concerned that changes in South Portland's dog beach laws have caused more dog owners to visit Cliff House Beach. Not advocating for absolute control of dogs or uncontrol of dogs. Recommends continuing work on the issue – look at both sides. Likes the conservation committee's soft approach and suggestions of good behavior.
