**Public Hearing Citizen Petition – Petition for Enactment of Ordinance to Limit
Disposition of Shoreline Access Real Estate**

Chairman Garvin opened the public hearing at 7:03 p.m.

Richard "Nick" Bryant, 55 Spurwink Avenue, Representing SOS
Mr. Bryant provided an overview of the citizen petition and urged the town council to adopt the ordinance.

Jim Morra, 5 Waumbek Road encouraged the town council to adopt the ordinance rather than holding an election in June with a lower turnout or waiting until November.

Colette Howe, 17 High View Road, member of SOS stated why the petition was started. The town needs to look at how we vote; a simple majority is too close to call for shoreline access. The super majority will build strong consensus. The town council is urged to adopt the ordinance on February 11.

Mary Ann Lynch, 2 Olde Colony Lane doesn't like to tie the hands of the town council however signed the petition. The petition was a way to show how the citizens feel on the issue. The paper street should be accepted. The town council is urged to adopt the ordinance on February 11, if not the vote should take place June 2019 with the school budget.

Sarah MacColl, 4 Avon Road favors the ordinance. Access to the shoreline is increasing in importance.

Priscilla Armstrong, 18 Avon Road encourages the town council to adopt the ordinance on February 11. The ordinance ensures greater discussion making and buy-in from citizens.

Anita Pettitt, 8 Katahdin Road said the ordinance is reasonable and encourages the town council to adopt on February 11.

Jodi Breau, 5 Waumbek Road, President SOS thanked Mr. Bryant for his assistance. This is the second citizens petition – citizens are asking for shoreline protection. The town council is urged to adopt the ordinance on February 11.

Mike Thorne, 15 High View Road, affiliated with SOS said there is a huge amount of interest in land issues in town. The group is trying to keep this a low-key issue however if not adopted could get a lot of press. The town council is urged to adopt the ordinance.

Robert Cronin, 7 Avon Road, member of SOS stated this is of major importance, a super majority makes sense.

After hearing no further comments, the hearing was closed at 7:27 p.m.

**Item #38-2019 Citizen Petition – Petition for Enactment of Ordinance to Limit
