Traffic count remains unchanged from year to year due to expected commerical vehicle visit increases being offset by increasing fees.

Minibuses are primarily local senior citizen (taxpayers) transports, many of which do a "drive by" and do not offload passengers.

Currently, there is 1 trolley company w/ 3 trolleys. On average, 8 visits per day with 18 passengers per visit > (209d \* 8 visits \* 18 passengers = 30K visitors)
