Town Council Reports and Correspondence

Councilor Penelope Jordan asked if the town manager had followed up with the code enforcement officer relating to short term rentals as discussed by members of the Richmond Terrace neighborhood on July 8. CEO Ben McDougal will be reporting to the town council within the next couple of months. Jim Rowe, President Cape Elizabeth Historical Preservation Society contacted the town council to see if the town will be participating in celebrating the State of Maine Bicentennial. The town council will discuss at a future workshop.

Councilor Gabrielson reported the GPCOG Metro Coalition will be meeting tomorrow to discuss the housing needs for the asylum seekers that were placed at the Portland Expo. The deadline for the availability of the Expo is nearing. Town Manager Sturgis will be attending the meeting.

Chairman Garvin reported he has received a couple of comments from citizens relating to traffic and parking for the Beach to Beacon Road Race. Although the town has no role in the logistics, concerns will be forwarded to the organizers. The town council has also received communications from a resident.

Finance Committee Report

Councilor Straw, Finance Committee Chairman reviewed the dashboard and monthly reports. The Current Year % of Budget column needs to be updated. Gross pay and display revenues will be replaced with net revenues.

Citizen Opportunity for Discussion of Items Not on the Agenda

Bill Goodykoontz, 55 Cross Hill Road said he sent an email to the town council relating to the Shore Road/Route 77 intersection however has not received a response. He asked the status of a review of the Route 77/Scott Dyer Road/Shore Road intersection to improve safety.

Jim Sparks, 14 Woodcrest Road and Mohammad Nasir Shir, 41 Ocean House Road, representing Cape Diversity Coalition provided a letter to the town council signed by 9 members thanking the town council for the \$5,000 contributions to both the Preble Street Resource Center and Opportunity Alliance approved on July 8. Suggestions for future contributions is to let citizens know so they have an opportunity to match the funds.

Town Manager's Monthly Report

As we close in on the end of summer, there are many items to report on.

Scott Dyer Road construction will be wrapping up work on Phase two this week, with safety improvements, drainage improvements, and an improved travel surface. The one caution I will raise is be careful of increased speed due to the new pavement.

Tax Assessor Clinton Swett committed taxes, and the 2019-2020 tax bills are coming this week. The positive news to report is the new mil rate is \$19.68, and it is eight cents less than anticipated. Tax due dates will be October 1, 2019 and April 1, 2020, with an interest rate for late payments of 9%, as set by the Legislature.

The Town Offices will be closed this Thursday, August 15 for the full day as staff will perform annual training. The focus is on customer service and mandatory sexual harassment training. Later in the morning the annual employee appreciation day and service awards luncheon will take place at the Fort.

The Thomas Memorial Library will be closed August 31 for the day as a deep cleaning of the facility will take place with all of the carpets being cleaned and will require some time to dry.

I am meeting this week with Josef Chalat and representatives from the Cape Elizabeth Historical Preservation Society to review proposed updates and renovations to the Spurwink School building, working to advance this project.

Staff is finalizing its preparations for the annual audit, which will begin August 26, with the auditors planning to be here for the week.

On July 22 the paper streets case was argued in the Business Court, with two counts under consideration. The Town prevailed in the first count due to the Court finding the claim of adverse possession as unsupported. In the second count the Court found the argument as unripe, as the Town has only extended its incipient rights of dedication. On Friday, August 9th initial filings for appealing this decision to the Law Court were filed.

Readers may notice a new function of the financial dashboard, information on the revenues from pay and display parking. This month it shows the gross revenues, while next month it will provide the net proceeds after expenses. One will note gross revenues for the month of July as \$122,670.

Finally, I have been participating in a local work group of GPCOG communities investigating the conversion to LED street lights. We recently interviewed four providers of such lighting and it makes excellent business sense to continue investigating the cost savings and pay / back options. I will have more to report as these discussions continue.

Public Hearing Proposed Amendments to Chapter 7 Dogs

Chairman Garvin opened the public hearing at 7:27 p.m.

Roger Caouette, 357 Fowler Road said dogs should be considered as part of the family. With all the restrictions, he no longer feels welcome. Restrictions are on everyone including those who are responsible dog owners. The public hearing should have taken place in September when residents return from vacation.

Roger Rioux, 5 Bridlepath Way (dog owner) said athletic fields should be off limits for the health of the field and humans. What is the category of the multipurpose field at Fort Williams? This field should also be off limits to dogs. Except for service dogs, voice control is non-existent. Perhaps off leash in gated areas in Fort Williams Park can be considered in the future.

Bill Goodykoontz, 55 Cross Hill Road doesn't understand why children and dogs can't play on the same field. Some dogs are under voice control.

Roger Rioux clarified his point that dogs and children can play together however dogs should be off limits on athletic fields for health reasons.

Tom Meyers, 4 Sea View Avenue said there is great wisdom in the way the categories were developed. Has the town council received any other comments?
